as follows:

Within the jurisdiction of Mandi Police Station the
complainant lodged complaint stating that near Arfath

mosque one Kudrath was running computer game center in his house by installing 8 computers by charging Rs.10/- per hour, six month back when CW1 was playing computer games there was quarrel between CW6 and juvenile outside the computer center, at that time when CW1 intervened to pacify the quarrel, therefore, the juvenile developed ill-will against CW1, on that background on 11.05.2021 at about 10.30 p.m., when CW1 was talking with CW6 and CW3 near scrap shop of one Idayath situated at MKDK road, you the Accused No.1 and 2 came near CW1, then Accused No.2 picked up quarrel with CW1 and assaulted on CW1's face, at that time CW6 and 3 intervened and pacified the quarrel and thereby you the accused No.1 and 2 **with your common intention** have committed the offence punishable **under Section 323 R/w.Sec.34 of I.P.C.**, within my cognizance.

Secondly, on 11.05.2021 at about 10.30 p.m., when CW1 was proceeding along with CW3 and 6 within the jurisdiction of Mandi Mohalla, on Srinivasa Temple Road, near Sultan park, all of a sudden you the Accused No.1 and 2 came near CW1 and with an intention to commit murder of CW1 you the Accused No.1 assaulted CW1 with chopper on his left hand and caused simple injuries and thereby you the accused persons **with your common intention** have committed the offence punishable **under Section 324 R/w.Sec.34 of I.P.C.**, within my cognizance.

Thirdly, on the aforesaid date, time and place when CW1 was proceeding along with CW3 and 6 within the jurisdiction of Mandi Mohalla, on Srinivasa Temple Road, near Sultan park, all of a sudden Accused No.1 and 2 came near CW1 and with an intention to commit murder of CW1 you the Accused No.2 assaulted CW1 with iron knife on CW1's back(ಪೊಂಟ) and caused grievous injuries and thereby you the accused persons **with your common intention** have committed the offence punishable **under Section 326 R/w.Sec.34 of I.P.C.**, within my cognizance.

Lastly, on the aforesaid date, time and place when CW1 was proceeding along with CW3 and 6 within the jurisdiction of Mandi Mohalla, on Srinivasa Temple Road, near Sultan park, all of a sudden you the Accused No.1, 2 and juvenile came near CW1 and with an intention to commit murder of CW1 you the Accused No.1 assaulted CW1 with long like chopper on his left hand, you the Accused No.2 assaulted CW1 with iron knife on his back(ಪೊಂಟ) and juvenile assaulted CW1 with iron rod on his person and caused grievous and simple injuries to CW1 and thereby you the accused persons **with your common intention** have committed the offence punishable **under Section 307 R/w.Sec.34 of I.P.C.**, within my cognizance.

And I hereby direct that you are be tried on the above said charges.
