O R D E R

1. Perused the application and say thereon vide Exh.4. Heard

the learned counsel Miss Anjali Mishra for the applicant/accused and the learned APP Miss R.S.Kanojia for the state. I have gone through the application, report and the case diary. It is seen that the present applicant/accused along with the other accused alleged to have been committed the offences punishable u/s 370(3) r/w 34 of the I.P.C alongwith 3, 4 & 5 of the Immoral Traffic (Prevention) Act,1956 in which the accused is arrested on 31/10/2020 and since then he was in PCR & now he is in MCR.

2. It is pertinent to note here that the report lodged by the PC namely Ashwin Kadam Dt.31/11/2020 alongwith the statements of the victims and other witnesses etc clearly shows that the complainant raided the spot of the incident on 31/10/2020 at about 06.30 P.M at Flat No. A/202, 2nd Floor, Parl Arcade, Opposite P K Jewellers, Andheri (West), Mumbai wherein he found that the present applicant/accused alongwith other accused are doing the prostitution business by which Investigation officer is prepared the spot cum seizure panchnama and took the custody of 2 to 3 girls. No doubt, the statements of the victim girls reads that the present applicant/accused alongwith other accused did the said business of the prostitution through them on payment.

3. Needless to say that the offence is serious & relating the women trafficking and illegal activities in the said premises but the investigation is in progress whereby there is every possibility that the present applicant/accused may tamper with the prosecution witnesses & evidence if he is released on bail at least at this stage which affect the case of the prosecution on merit.

4. In such circumstances, I am of the view that this is not the

fit case in which the accused can be released on bail u/s 439 of The Cr.P.C at least at this stage & thus I proceed to pass the following order.

ORDER

The application is hereby rejected.
