as follows:

That on 13.09.2024 at 05.00 P.M, within the jurisdiction of T.Narasipura Police Station at Doddebagilu Village at Schedule caste street, when CW1 was in house, you the Accused No.1 suddenly trespassed into CW1's house and thereby you have committed the offence punishable under Section 329(4) of BNS within my cognizance.

Secondly, on the aforesaid said date, time and place, you the accused No.1 trespassed into CW1's house and then from back side door you the Accused No.1 dragged CW1 out of the house by holding her hair and kicked on her stomach and voluntarily caused injuries and thereby you have committed the offence punishable under Section 115(2) of BNS within my cognizance

Thirdly, on the aforesaid said date, time and place, you the accused trespassed into CW1's house and then from back side door you the Accused No.1 dragged CW1 out of the house by holding her hair and kicked on her stomach and tried to outrage her modesty and thereby you have committed the offence punishable under Section 76 of BNS within my cognizance

Fourthly, on the aforesaid said date, time and place, you the accused persons with your common intention, you the Accused No.1 trespassed into CW1's house, dragged her out of the house by holding her hair(tuft) and kicked on

her stomach, at that time you the Accused No.2 and 3 caught hold of CW1 and wrongfully restrained her from further proceeding and thereby you have committed the offence punishable under Section 126(2) R/w.Sec.3(5) of BNS within my cognizance.

Fifthly, on the aforesaid said date, time and place, you the accused persons with your common intention, instigated Accused No.1 to assault and kill CW1 stating that she is not willing to compromising the case, if she is alive then only she can give evidence against them in the Court and you the Accused No.1 took club and threatened CW1 to compromise the case and warned if she is alive then only she can give evidence to court, hence you Accused No.1 will kill her and caused alarm and thereby you have committed the offence punishable under Section 351(2) R/w.Sec.3(5) of BNS within my cognizance

Lastly, on the aforesaid said date, time and place, you the accused persons with your common intention, intended to take away her life and assaulted with club on her left leg, and voluntarily caused hurt and abused in filthy language and picked up quarrel and gave life threat if she refuses to compromise the case, you the Accused threatened to take away her life and knowing fully well that such provocation will cause her to break the public peace, or to commit any other offence, and thereby you have committed the offence

punishable under Section 352 R/w.Sec.3(5) of BNS within my cognizance

And I hereby direct that you are be tried on the above said charges.
