Secondly, on the aforesaid date time and place, you the accused No.1 and 2 knowingly lived wholly or in part on the earnings of prostitution carried on by the women engaged by you and thereby you the accused have committed the offence punishable under Section 4 of the Immoral Traffic Prevention Act, within my cognizance.

Thirdly, on the aforesaid date time and place, you the accused No.1 and 2, procured, induced and took the women

including CW6 and CW7, for the purpose of prostitution by offering them money and engaging them in prostitution and thereby you the accused have committed the offence punishable under Section 5 of the Immoral Traffic Prevention Act, within my cognizance.

Lastly, on the aforesaid date time and place, you the accused No.1 and 2 for the purpose of exploitation, recruited and employed accused Nos.3 and 4 and procured CW6 and CW7 by offering her money and engaged her in prostitution and thereby you the accused have committed the offence punishable under Section 370(1) of IPC, within my cognizance.

And I hereby direct that you are be tried on the above said charges.
