

Vide application U/Sec.457 of Cr.P.C. and for the reasons stated thereunder the Applicant by name Sri Srinivas V N @ Seena, S/o Late V.T.Narayan, prayed to release the Maruti Wagon Car, bearing Reg.No.KA-04-ML-0807, Engine No.K1OBN7167586, Chasis No.MA3EWDE1500432778, Item No.1 in Cr.No.34/2023 subjected at PF No.35/2023 and Vivo and Oppo Mobile subjected at PF No.30/2023 in Item Nos.2 and 5 enclosed the copies of necessary documents, i.e. bills of purchase of said mobiles and RC of the said Car.

The Applicant is the absolute owner of the said vehicle Maruti Wagon Car, bearing Reg.No.KA-04-ML-0807 and Vivo and Oppo Mobile and the Applicant undertakes that he is ready and willing to abide by the conditions that may be imposed by the Court and he further undertakes that he is ready to execute indemnity bond for the value of the same and the Applicant require the above said vehicle for his daily use and they are in the custody of the Respondent Police without any care and protection and he also undertakes to produce photographs of the said vehicle before the Investigating

Officer with negative and the same may be summoned during the trial, if required.

The learned P.P. has opposed the application and for the reasons stated in the objection prayed to reject the application.

On consideration, it is undisputed about the seizure of the vehicle and mobiles subjected at PF No.30/2023 and 35/2023. Except the applicant there are no other rival claimants. This matter is of the year 2023 and in the event of rejecting the application, the vehicle will be spoiled in the police station premises and there is no impediment to release the vehicle and mobiles with conditions. Hence, the following:-

ORDER

The application dated 20.12.2023 filed by the Applicant by name Sri Srinivas V N @ Seena, S/o Late V.T.Narayana, U/Sec.457 of Cr.P.C. is hereby **ALLOWED**.

The Applicant shall execute Indemnity Bond for Rs.5,00,000/- (Rupees Five lakh only) and a surety for likesum before the I.O. of the concerned Police Station.

The Applicant shall not sell, change the colour, model, shape or anything of the Maruti Wagon Car, bearing Reg.No.KA-04-ML-0807, Engine No.K1OBN7167586, Chasis No.MA3EWDE1500432778 subjected at PF.No.35/2023, Item No.1 or transfer the said vehicle by any mode and also not to sell or change the identity of the said Vivo and Oppo Mobiles subjected at PR No.30/2023 item No. 2 and 5, till disposal of this Case.

The Applicant shall produce the Maruti Wagon Car, bearing Reg.No.KA-04-ML-0807, Engine No.K1OBN7167586, Chasis No.MA3EWDE1500432778 subjected at PF.No.35/2023 Item No.1 and Vivo and Oppo Mobiles subjected at PR No.30/2023 item No. 2 and 5, whenever directed either before the I.O. or before this Court without fail.

The Investigating Officer is directed to obtain the photograph of the Car and mobiles with CD, at the cost of the Applicant.

The I.O. is directed to release Maruti Wagon Car, bearing Reg.No.KA-04-ML-0807, subjected at PF.No.35/2023 and Vivo

and Oppo Mobiles subjected at PR No.30/2023 item No. 2 and 5, in favour of the Applicant by name Sri Srinivas V N @ Seena, S/o Late V.T.Narayana and after due identification and to keep the copies of the documents and photographs and to produce before the Court.
