**CROSS EXAMINATION BY: SRI. RK LEARNED COUNSEL FOR RESPONDENT:**

1. My date of birth is 02.05.2005. I am a resident of Gargeshwari Village, T.Narasipura Taluk. I have been residing at Mysuru since 2019. I do not know the door number of the house where I reside at Mysuru. I was working as a labor and also used to take up other coolie works. I used to earn Rs.600/- to 700/- per day by doing coolie work. It is false to suggest that my assertion regarding my income and avocation prior to the accident are all false.

2. I am not in a position to work now as such the question of my income increasing in the recent past does not rise. My relative was riding the motorcycle at the time of accident. The said motorcycle belonged to one Sri.Firdose Jahan. It is false to suggest that the person who was riding the motorcycle at the time of accident possessed a valid and subsisting D.L. Both of us were wearing helmets at the time of accident.

3. The FIS pertaining to the accident was lodged by my father. It is true to suggest that the spot where the accident occurred has heavy traffic movement and is a busy road. It is false to suggest that as the road is busy with heavy traffic movement it is not possible to drive the vehicles at a high speed. It is false to suggest that the accident occurred when the rider of the motorcycle on which I was proceeding rode the same at a high speed and in a rash or negligent manner and

dashed his vehicle against stationary bus. Immediately after the accident I was taken to Govt. Hospital T.Narasipura and thereafter I was admitted to K.R. Hospital, Mysuru. At K.R. Hospital I underwent treatment as an inpatient for 12 days. It is false to suggest that I had fully recovered from the injuries sustained in the accident at the time of my discharge from the Hospital. Witness states that I was advised regular follow up treatment.

4. I have taken follow up treatment around 5 to 6 times on OPD basis at K.R. Hospital. I do not remember as to when was the last time I consulted doctor for follow up treatment. I might have consulted the doctors about 3 to 4 months back. It is true to suggest that when I last consulted the doctors I was informed that the wounds have healed. It is false to suggest that I have fully recovered from the injuries now. Witness states that now I experience dizziness and my eyes go dark while doing any work.

5. It is false to suggest that the rider of the motorcycle was conversing over the phone at the time of accident as such he was not concentrating on the road thereby leading to the accident. I have not undergone any surgery for the injuries sustained in the accident. It is false to suggest that I have not incurred medical expenses to the extent forthcoming from the medical bills, yet the bills have been procured to suit my claim for higher compensation.

6. It is false to suggest that I have not suffered disability due to injuries sustained in the accident and yet I have deposed false facts

just to claim higher compensation. It is false to suggest that I am in a position to do all the work which I was doing prior to the accident and hence I am not entitled for any compensation.

7. It is false to suggest that even now I am doing the very same work which I was doing prior to the accident and I am earning more income than what I was earning prior to the accident and yet I have deposed false facts before this court. It is false to suggest that I have not suffered disability due to injuries sustained in the accident and yet I have deposed false facts just to claim higher compensation. It is false to suggest that I am in a position to do all the work which I was doing prior to the accident and hence I am not entitled for any compensation. It is false to suggest that I have got lodged a false FIS and on the basis of created documents I have filed this false petition and deposed false facts in support of the same.
