**CROSS EXAMINATION BY: SRI. JSK LEARNED COUNSEL FOR RESPONDENT NO.2:**

1. It was around 10.30 PM to 11 PM when the accident occurred. I do not recollect as to who got me admitted to the Hospital. As per my knowledge I was directly taken to Govt. Hospital, Madikeri after the accident. The accident occurred at Gonikoppa town. After about 4 days of occurrence of the accident I was taken to CHC, Gonikoppa.

2. The spot where the accident occurred is situated at a distance of about 500 meters from CHC, Gonikoppa. My hometown is Kodagu. I studied at Mysuru. Except for having obtained treatment at Govt. Hospital, Madikeri and CHC, Gonikoppa I have not obtained treatment at any other Hospital for the injuries sustained by me in the accident.

3. I have studied upto II PUC. I underwent treatment as an inpatient at a Govt. Hospital, Madikeri for a day. I have impediment to produce the documents pertaining to treatment obtained by me at Govt. Hospital, Madikeri as well as CHC, Gonikoppa as it has been 3 years since then. It is false to suggest that immediately after the alleged accident I was taken to CHC, Gonikoppa and not to Govt. Hospital, Madikeri as is being claimed by me.

4. It is false to suggest that at the time of accident I was highly inebared as such I do not recollect as to what happened to me. It is false to suggest that in the medical records issued by CHC, Gonikoppa it is specifically mentioned that at the time of my

admission to the Hospital I was under heavy influence of alcohol. Witness states that after the accident I was taken to Govt. Hospital, Madikeri.

5. It is false to suggest that as per my wound certificate issued by CHC, Gonikoppa which is exhibited as Ex.P4 I had sustained only simple injuries. At the time of accident I was proceeding by walk. I do not recollect as to from which side the car came before causing the accident. It is true to suggest that on either side of the road where the accident occurred there is Kaccha road i.e., untarred road. The accident occurred on the tar road. The point of impact is situated at a distance of about 1.5 to 2 feet from the left edge of the road. I did not observe the vehicle approaching before it caused the accident.

6. Upon being questioned that as per the police records at the time of accident myself and PW.1 were standing and conversing with each other whereas according to me I was proceeding by walk which of the two versions is true, witness states that the version that I was proceeding by walk is true.

7. I am the informant. The police informed that the accident was caused by a car. I was informed that the police had verified the CCTV footages and on that basis they ascertained that the accident was caused by a car. The person who caused the accident had come to my house after about 1 week of occurrence of the accident but even prior to that the police had informed me that the accident was caused by said car. I have not disclosed the fact that the person who caused the accident had come to my house after about 1 week of occurrence of

the accident before the I.O. or anybody else. I am stating the said fact before this tribunal for the first time.

8. It is false to suggest that despite the fact that the accident occurred due to my negligence in walking on the road under the heavy influence of alcohol, I have pleaded and deposed false facts just to suit my claim.

9. It is false to suggest that due to injuries sustained in the accident, I have not sustained any serious injuries which could have resulted in any permanent partial physical disability. Witness states that I am not in a position to do any work. Except for the documents already got exhibited by me I have no other documents available with me with regard to the treatment obtained by me for the injuries sustained in the accident. I do not recollect the name of the doctor who treated me for the injuries sustained in the accident. It is false to suggest that with a sole intention of claiming higher compensation I have deposed false facts.
