Petition Claim: The petitioner prays this court to pass a judgment and award in favour of the petitioner thereby directing the respondents to pay the compensation amount of Rs.22,10,000/- along with interest at 18% p.a.,from the date of petition till the date of realization with costs and grant such other reliefs.

The petition coming on this the **02nd day of July 2026** for final disposal before **Smt.PRATHIBHA D.S., B.A., L.L.B., Judge, Addl. Court of Small Causes, Mysuru** in the presence of **Sri. N.M.Mahadeva** advocate for petitioner, advocate for R-1 ex-parte and **Sri.B.Kale Gowda** advocate for R-2 and **Sri.B.G.Kumar** advocate for R3..

On contest and by pronouncing the judgment, it is ordered and awarded that the petition is hereby **ALLOWED IN PART** with cost.

It is further ordered and awarded that, the petitioner is entitle for total compensation of **Rs.2,87,500/- (Rupees two lakhs, eighty seven thousand and five hundred Only)** along with interest at the rate of 6% p.a., from the date of petition till its realization.

It is further ordered and awarded that, the respondent No.1 and 3 are jointly and severally liable to pay the compensation amount to the petitioners. The respondent No.3 being the insurer is liable to indemnify the respondent No.1 and to deposit the compensation awarded within a period of 30 days.

It is further ordered and awarded that, out of the compensation amount awarded to the petitioners owing to the medical expenses incurred by them no order as to deposit. On being deposited it is ordered to release entire amount in favour of petitioners on proper identity and verification.

The advocates fee is fixed at Rs.1000/-.
