**Petition Claim:** The petitioner prays this court to pass a judgment and award in favour of the petitioner thereby directing the respondents to pay the compensation amount of Rs. 15,25,000/- along with interest at 12% p.a., from the date of petition till the date of realization with costs and grant such other reliefs.

The petition coming on this the **30<sup>th</sup> day of April 2026** for final disposal before **Smt. PRATHIBHA D.S., B.A., L.L.B., Judge, Addl. Court of Small Causes, Mysuru** in the presence of **Sri.M.Suresh** advocate for petitioner, **Sri.H.M.Madegowda** advocate for R-1, **Sri.Vishwanatah.V** advocate for R-2.

On contest and by pronouncing the judgment, it is ordered and awarded that the petition is hereby **ALLOWED IN PART** with cost.

It is further ordered and awarded that, Petitioner is entitled for total compensation of Rs.6,33,000/- [Rupees six lakhs and thirty three thousand only] along with interest at the rate of 6% p.a. from the date of the petition till realization of entire amount.

It is further ordered and awarded that, the respondent No.1 and 2 are jointly liable to pay the compensation amount to the petitioner. The respondent No.2 being the insurer is liable to indemnify the respondent No.1 and to deposit the compensation awarded within a period of 30 days.

It is further ordered and awarded that, considering the amount spent towards medical expenses there shall be no order for investment, accordingly on deposit being made, office is directed to release the entire amount to the petitioner on proper identification.

The advocates fee is fixed at Rs.1000/-.
