1. Does the plaintiff prove that the suit schedule properties are the ancestral and joint family properties of the plaintiff and defendants?
2. Does the defendant no.1 prove that his father gifted the item no.1 and 2 of the suit properties in favor of his sister Ningamma vide Gift deed dated 29.12.2000?
3. Does the defendant no.1 prove that item no. 3 and 4 of the suit properties are the self acquired properties of the defendant no.1?
4. Does the defendant no.1 prove that the plaintiff and her mother in law have relinquished their share in the item no. 1 and 2 of the suit properties by the receiving cash at the time of relinquishment deed dated 19.03.2004 as pleaded in the para no. 7 of the WS?
5. Is the plaintiff entitled to the relief of partition and separate possession of 1/5th share in the suit properties?
6. To what shares the defendants are entitled?
7. To what relief the parties are entitled?
8. . What Order or Decree?
