1. I worked as Branch Manager from the date of 02.06.2013 to 19.09.2014 in State Bank of India, Hunsuru.
2. I do not know CW13. I do not know the accused. I have not seen him before. The signature found on the EXP114 is mine and the same is marked at EXP114{B}. I made this signature 31.12.2013 between 11.15 a.m to 12.00 in the noon at Hunsuru Branch SBI. Some police from Hunsuru Town Police Station had come to me and inquired for Demand draft Br.NO.137413 dtd: 29.12.2010 for an amount of Rs. Rs.57,646/-. Accordingly I produced the same before the police and the police men explained me the same in Hindi since I do not know Kannada and Accordingly police conducted Mahazar and seized the above mentioned D.D. and took my signature in EXp114.
3. Another document is shown to me is D.D.137413 Dtd; 29.12.2010 and the amount was Rs.57, 646/- which is already

marked at ExP115. This has been produced by me before the police and police have seized the same under the mahazar.
