COMMITTAL ORDER UNDER SECTION 232 OF BNSS

The Police Inspector of Bilikere Police Station has filed the final report against the accused No.1 to 5 for the alleged offence punishable under Sections 310(2) of BNS.

2. On receipt of the final report, cognizance was taken for the offence punishable under Section 310(2) of BNS and as there were prima-facie grounds to proceed against the accused No.1 to 5 for the above said offences, a criminal case was registered against the accused No.1 to 5. The accused No.1 to 5 are in JC.

3. Perused the materials on record.

4. On perusal of the materials on record, it reveals that, the offence punishable under Section 310(2) of BNS is exclusively triable by the Hon'ble Court of Sessions. Hence, as per proviso of Sec.232 of BNSS, the case is

committed within 90 days from the date of taking cognizance, to the court of Hon'ble VIII Addl. District and Sessions Judge, Mysuru sitting at Hunsur for trial. Accordingly, I proceed to pass the following:

ORDER

Acting under Section 232 of BNSS, the case is committed to the court of VIII Addl. District and Sessions Judge, Mysuru sitting at Hunsur for trial.

Office is hereby directed to submit the entire records along with the properties, if any, to the Hon'ble VIII Addl. District and Sessions Judge, Mysuru sitting at Hunsur and intimate the fact of committal of the case to the Learned Asst. Public Prosecutor.

Accused No.1 to 5 are remanded to JC till further orders by the Hon'ble VIII Addl. District and Sessions Judge, Mysuru sitting at Hunsur.

Jail Authorities are directed to produce the accused No.1 to 5 before the Hon'ble I VIII Addl. District and Sessions Judge,

Mysuru sitting at Hunsur whenever directed
to do so.
