ORDER

The Petitioners have filed this petition seeking
issuance of directions to respondent to enter the date of



death of Halagegowda S/o Late Gange Halagegowda, Father of the Petitioners herein. The said Halagegowda died on 06/05/1990, at Kalyanapura Village, Arjunahalli Post, Hosa Aagrahara Hobli, K.R Nagar Taluk, Mysuru District.

The notice to the respondent was duly served. In spite of service of notice, respondent failed to appear before this court and to contest the matter. Public notice through paper publication was issued in two papers on 14/04/2026 in Rajya Dharma and Praja Sathya daily news papers. However, the respondent was called out absent and was placed ex-parte. The 2nd Petitioner has examined himself as PW-1 and got marked documents Ex.P1 to 7, 7(a), Ex.P1 is the non-availability certificate, Ex.P2 is the G-Tree, Ex.P3 is the Death certificate, Ex.P4 and 5 are the Notarized copies of the Aadhar Cards of the petitioners, Ex.P-6 and 7 are the copies of the paper publications and Ex.6(a) and 7(a) are the portion of notices, PW-1 has reiterated the averments of the petition in his examination-in-chief. As the respondent did not choose to appear and contest the matter. The evidence of PW-1 remained unchallenged. There is nothing available on record to disbelieve the version stated by the 2nd Petitioner on oath. Apart from this, the explanation given by the Petitioners for not informing the date of death to the concerned authorities is also satisfactory one.



The Petitioners are the competent persons to depose regarding the death of Halagegowda S/o Late Gange Halagegowda, Father of Petitioners herein. Hence, in the opinion of this court the petitioners have made out sufficient grounds so as to issue the directions to the respondent authority as prayed for in the petition. Hence, this court proceeds to pass the following:

ORDER

- The petition filed by the Petitioners is hereby allowed.
- The respondent is hereby directed to register the date of death of Halagegowda S/o Late Gange Halagegowda, Father of the Petitioners herein. The said Halagegowda died on 06/05/1990 at Kalyanapura Village, Arjunahalli Post, Hosa Aagrahara Hobli, K.R Nagar Taluk, Mysuru District and issue death certificate to the Petitioners accordingly after payment of necessary fees.
