

Order Below Exh.1 in SCC No.1879/2022.

In view of direction issued by the Hon'ble High Court Bombay vide letter No.1001/2025/1684 dated 02.09.2025 this case is taken up for special drive.

2. Perused the record. There is no CA report filed along with final report, which is prime evidence. Therefore, no fruitful purpose would served by commencing the procedure of the case. Hence, under this situation, in my view, it is fit case to exercise powers under section 258 of the Code of Criminal Procedure. Hence, the following order.

ORDER

1. The proceeding is stopped and accused is discharged vide section 258 of the Code of Criminal Procedure for the offence punishable under section 65- (d) of the Maharashtra Prohibition Act.

2. Cash security bond of the accused stands cancelled and its amount be returned to the accused.

3. The seized muddemal at Sr.No. 1 be destroyed in accordance with law after appeal period is over.
