CAUSE OF ACTION:

Cause of action for the suit arose on and from first week of June 2025 and subsequently within the jurisdiction of this Hon'ble Court.

The relief of mandatory injunction and mandatory are valued under Section 24(d) of Karnataka Court Fees and Suits Valuation Act. Hence a court fee of Rs.50/- paid.

necessary formalities, if any, as required under law.
