This suit is filed by the plaintiff against the defendant praying for setting aside all the contentions of the defendant decree may be kindly be passed, directing the defendant to pay Rs.7,68,709/-, as shown in the accompanying account extract with future interest at the rate of 18% per annum from 01.06.2025 till realization of entire amount and till his actual receipt and such other reliefs.

This case having been referred to Lok-Adalath is coming on this 11<sup>th</sup> day of July 2026 for final disposal before Shri. Subhash Sankad, B.A., LL.M., Judicial Conciliator/Presiding Officer of Ist Additional District and Sessions Judge, Belagavi and Smt. Pratima Joshi, Advocate Conciliator and in the presence of Sri M.B. Patil, Advocate for Plaintiff and Sri S.N. Pattar Advocate for defendant.

**TERMS of COMPROMISE**

1. The Plaintiff and Defendant have agreed to settle their dispute amicably among themselves in following manner.
2. The Defendant admits that, there was an out standing balance of Rs.7,68,709/- due to Plaintiff from the defendant as on 31<sup>st</sup> May 2025.

3. The Defendant agreed to pay balance due amount in installments for which Plaintiff has agreed.
4. The defendant has agreed to pay a sum of Rs. 30,000/- per month regularly till the realization balance amount.
5. The Defendant has further agreed to pay a sum of Rs. 1,00,000/- today towards balance amount.
6. Both parties to suit have agreed that, in default of any installments the Plaintiff is at liberty to execute the decree for remaining amount through court of law.

**IT IS ORDERED AND DECREED THAT**

*The matter is taken before Lok-Adalath.*

*Both the parties and their counsel present and filed a compromise petition U/o. XXIII Rule 3 of CPC.*

*Substance of the compromise petition is read over and explained both the parties.*

*Both the parties admitted the settlement between them in terms of the compromise petition and they executing the compromise petition.*

*Plaintiff acknowledged receipt of Rs. 1,00,000/- from the defendants in terms of the compromise petition.*

*We are satisfied that both the parties have voluntarily entered into the compromise and same has to accepted at the better interest of both the parties.*

*Accordingly, compromise petition filed by both parties U/o. XXIII Rule 3 of CPC is accepted.*

*The suit filed by the plaintiff is decreed in terms of the compromise petition.*

*Both the parties are directed to bear their respective cost.*

*Full court fee paid by the plaintiff is ordered to refunded to the plaintiff.*
