Suit claim: Suit was filed on 24/08/2018 by the plaintiff and prays to pass judgment and decree directing the ;

- a. Defendants No.1,2,3 and 4 to pay a sum of Rs.50,30,047/- (Rupees Fifty Lakhs Thirty Thousand and Forty Seven Only) and pay interest at the rate of 24% per annum for the principal amount of Rs.50,30,047/- (Rupees Fifty Lakhs Thirty Thousand and Forty Seven Only) from the date of plaint to till actual payment to the Plaintiff.
- b. To pay the costs of the suit
- c. To pass such further or other order

This suit coming on this day for final disposal before **SRI. ARJUN S. MALLUR, LXXXV Additional City Civil & Sessions Judge, Bangalore**, in the presence of Smt. Sonam Chandwani - Advocate for the Plaintiff; Sri. S. R. Raviprakash - Advocate for the Defendant No 2, Sri. L. Visweswaraiah, Advocate for the Defendant No 3, Smt. E. R. Pankajamani, Advocate for the Defendant No 4, D1-Ex-parte.

It is ordered and decreed that Suit of the plaintiff is decreed in part with costs.

It is further ordered and decreed that the Defendant Nos.1, 2 and 4 are jointly and severally liable to pay to the plaintiff a sum of Rs.50,30,047/- (Rupees Fifty Lakhs Thirty Thousand and Forty Seven Only) with interest at 24% p.a. from the date of suit till realization.

And that a sum of **Rs.2,04,081/-** to be paid by the defendant Nos.1, 2 & 4 to the Plaintiff on account of the costs of this suit.
