Firstly, that on 25-8-2011, during night hours, near JSS College, Deveerammanahalli extension, Nanjangud, you accused broke open the door lock of the house of Cw-1 Basa and by entering into the said house within the possession of said Cw-1 Basavanna used as human dwelling after the hour of sunset and before the hour of sunrise in order to commit theft punishable with imprisonment and thereby committed an offence punishable u/s 457 IPC and within my cognizance.

Secondly, on the said date, time and place, you accused by breaking open the door lock of the said house of Cw-1 Basavanna committed theft of 34 grams of gold chain and 703 grams of Silver articles kept in the almirah and thereby committed an offence punishable u/s 380 IPC and within my cognizance.
