This is an application filed on behalf of accused Rahimullah Rahimi seeking permission to wear winter essential i.e. winter cap from Tihar Jail to Patiala House Court and Lock up room.

Reply has already been received from the Incharge, Lock up, New Delhi District to the present application. In the report, it has been stated that accused may be allowed to wear single layer woollen cap; the cap must not contain any drawstring/cord that can be used as weapon; there must not be any place/pocket to hide any article and that accused may be allowed to wear winter cap.

In view of the above report, applicant/accused Rahimullah Rahimi is permitted to wear winter cap from Tihar Jail to Patiala House Court Lock-up with the abovementioned restrictions only as per jail rules.

Application is disposed of accordingly.
