ORDERS

The petitioner has filed this petition U/s 13(3)(B) of
Karnataka Births and Deaths Registration Act, 1969.

2. In the petition the petitioner has stated that she was born on 15-03-2008 at Hallare Village, Hullahalli Hobli, Nanjangudu Taluk, Mysore District. Due to lack of knowledge of parents of petitioner, the birth date was not entered in their registers. Now the petitioner is in need of her birth certificate to obtain Government facilities, hence she has approached the respondent for issue of birth certificate, the respondent had issued non-availability certificate. Hence she prayed to issue direction to issue birth certificate as sought in the petition.

3. On service of petition notice, the respondent has remained absent, hence the respondent is placed ex-parte.

4. The following points that arise for the consideration of this court are;

1. Whether the petitioner has made out grounds for issue directions as sought in the petition?

2. What Order?

5. The petitioner in support of her case, she has examined herself as Ex.P1 and relied on documents which are marked as Ex.P1 to Ex.P3.

6. Heard the arguments of learned counsel for the

petitioner, perused the materials on record.

7. The findings of this Court to the above points are as follows;

Point No.1 : In the **Affirmative**.

REASONS

8. **Point No.1:-** In support of her case, the petitioner has filed affidavit evidence in lieu of her examination-in-chief as PW.1. In her evidence she has stated that she was born on 15-03-2008 at Hallare Village, Hullahalli Hobli, Nanjangudu Taluk, Mysore District. Further, she has deposed that due to lack of knowledge her parents they have not registered her date of birth with the respondent authority. The petitioner is in need of her birth certificate to obtain Government facilities. When she applied for birth certificate, the respondent authority has issued non-availability certificate and therefore, she has filed this petition.

9. Further, during the course of her examination-in-chief, non-availability certificate is marked at Ex.P1, Notarized copy of School Admission Register Extract at Ex.P2 and Notarized copy of Aadhaar Card of petitioner is marked at Ex.P3. The evidence of petitioner has remained unchallenged and un-rebutted without

under going the test of cross-examination. Hence, this court is of the opinion that, the petitioner has established that she was born on 15-03-2008 at Hallare Village, Hullahalli Hobli, Nanjangudu Taluk, Mysore District, as such she is entitled for the relief as sought for. With these observations this court answered **Point No.1** in the **Affirmative**.

10. Point No.2:- For the aforesaid discussion on Point No.1, this court proceed to pass the following;

ORDER

The petition filed U/s. 13(3)(B) of Registration of Birth and Death Act, is hereby allowed.

The respondent is hereby directed to enter the date of Birth of petitioner i.e., Kum. Rakshitha D/o Sri. Mahadevanayaka and Smt. Geetha, was born on 15-03-2008 at Hallare Village, Hullahalli Hobli, Nanjangudu Taluk, Mysore District in the relevant registers maintained by the respondent, after collecting necessary fee if any.

Issue intimation accordingly.
