1. Today the proclaimed offender namely Krishna Chaudhary is produced before this Court on the strength of order passed by Judicial Magistrate First Class, Gurugram (UID NO.HR0534) dated 11.12.2025.
2. The Regular P.O is on leave. I am in-charge of this Court.
3. The I.O of this case along with Debasish Mallick Choudhary, Ld. Spl. PP for the NIA is present.
4. From the said order it appears that the accused was arrested on 10.12.2025 and he was produced before the Court of Judicial Magistrate First Class, Gurugram on 11.12.2025. That the NIA was granted transit remand till 14.12.2025 for producing the accused before this Court.
5. Perused the arrest memo, written ground of arrest, search and seizure memo, Add. General Diary Details and the endorsement of the medical officer, Gurugram. The accused namely Krishna Chaudhary is taken into custody in this case.
6. The order number 70 dated 01.06.2023 by which the case against this accused was filed for the present stands recalled.
7. The accused is un-represented. The Ld. Counsels from the LADCS are present to represent the accused.
8. The NIA files a petition praying for 5 days custody remand of the accused. Ld. Spl. PP for NIA moves the application.
9. It is submitted that this accused was arrested in connection with Manikchak P.S case number 06 of 2020 dated 06.01.2020.
10. Subsequently this accused was released on bail in connection with that case. The NIA initiated the instant case on 05.05.2020 being NIA case no. RC-22/2020/NIA/DLI.
11. Thereafter the case was transferred to the Court of Ld. Chief Judge, City Sessions Court cum-Judge Spl. NIA Court.
12. Subsequently this Court received this case by transfer but in this case the instant accused did never appear. After all the process to compel his attendance was exhausted by the order dated 01.06.2023 the instant accused along with another accused Situn Mondal @ Situ was declared a proclaimed offender and the case was filed for the present.
13. The instant accused was never available to the instant investigating agency i.e. NIA.
14. Ld. Spl. PP submitted that the purpose of further investigation custodial interrogation is required in the interest of investigation. It is prayed that 5 days remand may be granted.
15. Ld. Counsels from LADCS registered their objection against the prayer for remand.
16. The accused on being asked expressed that he is all well having no ailment.
17. Accordingly in the interest of investigation the prayer for remand of accused Krishna Chaudhary is allowed till 17.12.2025.
18. Let the accused person be handed over to the custody of the I.O.

19. The I.O is directed to strictly comply the direction of Hon'ble Apex Court as observed in D.K Basu Case. He shall cause the accused to be medically examined on every alternative date during the remand period and shall produce the accused before this Court on **17.12.2025**.
20. Hence the prayer for remand is disposed of.
21. Let a copy of this order be given to the I.O through Ld. Spl. PP and Ld. Counsels from LADCS.
