Pursuant to previous order, conduct report of last two years of applicant/accused has been received as per which his conduct is good and no punishment has been awarded to him till date.

It is submitted that the present matter is pending before this court and is fixed for today i.e. 29/04/2021 for PE. He has further submitted that the applicant/accused has been falsely implicated in the present case and he was never involved in the alleged offence in any manner whatsoever. He has further submitted that at the time of the alleged incident, the applicant/accused was not present at home, rather the daughter of the applicant/accused namely Prachi who is one of witness in the present case has made a statement that no quarrel took place between the applicant/accused and his deceased wife on 30/06/2016, who was present at home along with her minor daughter and was complaining of headache and she consumed some medicine after which she felt unconsciousness, daughter of applicant/accused called him, whereupon applicant/accused came home and took the deceased to doctor and after taking medicine the deceased got asleep and when she did not wake up, the applicant/accused and his daughter found that there was no movement in the body of the deceased. Id. Counsel has further submitted that present FIR is false and fabricated and there is no eye-witness to the incident. Id. Counsel has further submitted that material witnesses have been examined and they are supporting his case. He has further submitted that applicant/accused is languishing in JC since long time and after the death of his wife, there is no one in the family of the deceased to look after his children, who are aged 8 years and 11 years and the daughter of the applicant/accused is physically disabled and cannot move without any escort and she needs urgent care and attention of her father. He has further submitted that applicant/accused was granted interim bail for 45 days vide order dated 22/06/2020 and he surrendered himself after completion of interim bail period. Id. Counsel has further deposed that investigation in the present matter has been completed and the charge-sheet has been filed and therefore no fruitful purpose

:2:

would be served by keeping the applicant/accused anymore in J.C. He has further submitted that applicant/accused has clean and clear antecedents and no other FIR prior to the present FIR has been registered against him. He has further submitted that applicant/accused is permanent resident of Delhi and there is no chance of his absconding or tamper with the prosecution evidence, he undertakes to appear before the court or IO as and when required. Id. Counsel has further submitted that if regular bail cannot be granted at this stage, at least interim bail for two months may be granted to the applicant/accused for the purpose of taking care of his children and the present bail application may be considered as application for interim bail. He has lastly prayed for grant of two months interim bail to the applicant/accused.

On the other hand, Id. Addl. PP for the State has objected to the grant of interim bail/regular bail to the applicant/accused on the ground that there were injuries on the body of the deceased and cause of death was asphyxia due to smothering. He has further submitted that factum of applicant/accused living with wife is not denied. He has further submitted that regular bail cannot be granted at this stage as whole file is required to be gone through and only thereafter the regular bail may be decided.

Heard. The regular bail application of the applicant/accused cannot be decided because there are various other circumstances, which are required to be gone through, but keeping in view the fact that applicant/accused was granted interim bail in terms of the guidelines of HPC and he did not misuse the liberty so granted and also in view of the fact that he has two children, out of which, one daughter is handicapped and his presence is necessary to look-after them keeping in view circumstances created by COVID-19 pandemic & also in view of the fact that his conduct is good in jail for the last two years and no punishment is awarded to him till date, **a lenient view is taken against the applicant/accused and he is ordered to be released on interim bail for a period of two months on his furnishing personal bond in the sum of Rs. 50,000/- with one surety in the like amount.** The bail application is disposed of accordingly.
