COMMITTAL ORDERS U/s 232 of B.N.S.S.

The charge sheet filed by the T. Narasipura police, in Cr.No.327/2025 against accused for the offences punishable U/sec 115(2), 126(2), 352 and 105 of the B.N.S.

2. After filing of the charge sheet, I have perused the charge sheet and other police papers. It is case of prosecution that, on 25-09-2025 at about 8.00 pm, the accused abused the deceased Siddaraju and assaulted him and also kicked him and pushed him, for which the deceased was fell down on cement concrete mory for that he sustained grievous head injury and took treatment in hospitals and discharged from the hospital in Unconscious manner and died on 15.02.2026. After investigation the police have filed charge sheet along with ceased material objects.

3. There is a prima-facie case against the accused. Hence, cognizance taken u[s.210(1)(b) of B.N.S.S and the case is registered.

4. After taking cognizance the copy of the charge sheet and other police papers have been furnished to the accused as required u[s. 230 of B.N.S.S.

5. The accused is in J.C.

6. The offence alleged under Section of B.N.S is exclusively tribal by the Court of Hon'ble Session Court, Mysuru. Hence, it is just and necessary to commit the case above case under Section 232 of B.N.S.S to the Court of Hon`ble Prl. District and Sessions Judge, Mysuru. Hence, I proceed to pass the following:

ORDER

The case is committed under Section 232 of B.N.S.S to the Hon'ble Prl., District and Sessions Judge, Mysuru.

Office is Send the entire case files to the Hon'ble Prl. District and Sessions Judge Court, Mysuru, immediately.

Send the documents and articles and M.O.s produced by the I.O. as per P.R.No.43/2026 to the Prl. District & Sessions Judge, Mysuru, immediately.

Notify the committal order to the Public Prosecutor Mysuru, as required U/s. 232(d) of B.N.S.S.

The concerned jail authorities are directed to produce the accused before the Hon'ble Prl. District & Sessions Judge, Mysuru as and when directed to do so.
