**C H A R G E**

I, **Mahavir.M.Karenavar**, Senior Civil Judge & JMFC,  
T.Narasipura, do hereby charge you, as follows;

Firstly, that on 05.05.2017 at 02.30 pm, in the Village of Kargalli, within the limits of T.Narasipura Police Station, when CW-1 asked to supplied the water to her land, in furtherance of common intention, you accused picked-up quarrel with CW-1 and you accused No.1 kicked with your legs on her body and you accused No.2 & 3 beaten CW-1 on her body with your

hands and caused simple hurt and thereby you accused have committed an offence punishable U/Sec.323 of Indian Penal Code and within my cognizance.

Secondly, that on above said date, time and place, in furtherance of common intention, you accused No.1 assaulted CW-1 on her left shoulder with a stick which is used as a weapon of offence likely to cause death and caused simple injury and thereby you accused have committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code and within my cognizance.

Thirdly, that on above said date, time and place, in furtherance of common intention, you accused No.2 & 3 insulted CW-1 by pulling her hair and intent to outrage her modesty or knowing fully well that such act is sufficient to outrage the modesty of a women and thereby you accused have committed an offence punishable U/Sec.354 R/w Sec.34 of Indian Penal Code and within my cognizance.

Fourthly, that on above said date, time and place, in furtherance of common intention, you accused No.1 abused CW-1 in filthy language saying that, ಬಡ್ಡಿ ಸೂಳೆ etc., and thereby gave provocation to her intending or knowing it likely that such provocation will cause her to break the public peace or to commit any other offence and thereby you accused have committed an offence punishable U/Sec.504 R/w Sec.34 of

Indian Penal Code and within my cognizance.

Finally, that on above said date, time and place, in furtherance of common intention, you accused No. 1 to 3 criminally intimidated CW-1 by threatening to take away her lives, so as to cause alarm in her mind and thereby you accused have committed an offence punishable U/Sec.506 R/w Sec.34 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried on the said charge.
