C H A R G E

I, ***Mahavir.M.Karennavar***, Senior Civil Judge & JMFC,
T.Narasipura, do hereby charge you, as follows;

Firstly, that on 04.01.2019 at 09.00 am, near
Rajarajeshwari Medical Store, Main road, 5th ward,
T.Narasipura Town, within the limits of T.Narasipura Police
Station, when CW-1 was doing drainage work by that time you
accused picked up quarrel with CW-1 and wrongfully
restrained the movement of CW-1 from moving in a direction
with an intention to commit certain offence and thereby you
accused have committed an offence punishable U/Sec.341 of
Indian Penal Code and within my cognizance.

Secondly, that on above said date, time and place, you
accused voluntarily picked-up quarrel with CW-1 and

restrained him from discharging his duty as public servant, used criminal force against him and thereby you accused have committed an offence punishable U/Sec.353 of Indian Penal Code and within my cognizance.

Thirdly, that on above said date, time and place, you accused abused CW-1 in filthy language and thereby gave provocation to him intending or knowing it likely that such provocation will cause him to break the public peace or to commit any other offence and thereby you accused have committed an offence punishable U/Sec.504 of Indian Penal Code and within my cognizance.

Finally, that on above said date, time and place, you accused voluntarily caused hurt to CW-1 by scratching his face on your nails and beaten him with your hands on his body and deterred him from discharging his official duties and thereby you accused have committed an offence punishable U/Sec.332 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried on the said charge.
