C H A R G E

I, ***Mahavir.M.Karennavar***, Senior Civil Judge & JMFC,
T.Narasipura, do hereby charge you, as follows;

Firstly, that on 06.03.2018 at 08.00 pm, in the village of Kupya, within the limits of T.Narasipura Police Station, in front of house of CW-1, you accused No.1 & 2 assaulted CW-1 on her body with your hands by pulling her hair and you accused No.3 & 4 assaulted CW-1 with your hands by pulling

her and holding her neck strap and caused internal injury and thereby you accused have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code and within my cognizance.

Secondly, that on above said date, time and place, in furtherance of common intention, you accused No.1 & 2 wrongfully restrained the movement of CW-1 from moving in a direction with an intention to commit certain offences and thereby you accused have committed an offence punishable U/Sec.341 R/w Sec.34 of Indian Penal Code and within my cognizance.

Finally, that on above said date, time and place, in furtherance of common intention, you accused No.3 & 4 abused CW-1 in filthy language saying, ಲೋಪರ್ ಮುಂಡೆ, ಕತ್ತೆ ಮುಂಡೆ etc., and thereby gave provocation to her intending or knowing it likely that such provocation will cause her to break the public peace or to commit any other offence and thereby you accused have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried on the said charge.
