**C H A R G E**

I, **Mahavir.M.Karenavar**, Senior Civil Judge & JMFC,  
T.Narasipura, do hereby charge you, as follows;

Firstly, that you accused No.1 being the husband of C.W.1/Bhagya W/o Chandru having married her about 04 years back, after the marriage in the house of accused, Somanathapura Village, Sosale Hobli, T.Narasipura Taluk within the limits of Mysuru Women Police Station, in furtherance of common intention, you accused Nos.1 to 3 subjected CW-1 to cruelty in your house and picked up quarrel with CW-1 and acted cruelly by giving mental and physical torture to CW-1 and on 30.10.2017 at 09.00 am you

accused Nos.1 to 3 used to beat her and thereby gave mental agony, physical harassment to her and thereby you accused have committed an offence punishable U/Sec.498(A) R/w Sec.34 of Indian Penal Code and within my cognizance.

Secondly, that on above said date, time and place, in furtherance of common intention you accused Nos.1 to 3 beaten CW-1 with your hands on her body and caused simple injuries and thereby you accused have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code and within my cognizance.

Thirdly, that on above said date, time and place, in furtherance of common intention you accused Nos.1 to 3 insulted CW-1 by pulling and assaulting her and intent to outrage her modesty or knowing fully well that such act is sufficient to outrage the modesty of a women and thereby you accused have committed an offence punishable U/Sec.354 R/w Sec.34 of Indian Penal Code and within my cognizance.

Finally, that on above said date, time and place, in furtherance of common intention, you accused Nos.1 to 3 abused CW-1 in filthy language and thereby gave provocation to her intending or knowing it likely that such provocation will cause her to break the public peace or to commit any other offence and thereby you accused have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried on the said charge.
