C H A R G E

I, **Mahavir.M.Karenavar**, Senior Civil Judge & JMFC,
T.Narasipura, do hereby charge you, as follows;

Firstly, after the marriage of CW-1 with accused No.1 that is between the period of 2000 & 2007, in furtherance of common intention you accused persons being the husband and in laws of CW-1 ill-treated her by giving mental and physical torture and thereby gave mental agony, physical harassment to her and thereby you accused have committed

an offence punishable U/Sec.498(A) R/w Sec.34 of Indian Penal Code and within my cognizance.

Secondly, that on 10.09.2017 at 10.00 pm, in Thumbala Village, T.Narasipura Taluk, within the limits of T.Narasipura Police Station, in furtherance of common intention, you accused No.1 to 4 picked up quarrel with CW-1 and you accused No.2 & 4 held hair of CW-1 and your accused No.4 punched the head of CW-1 to the wall and scratched CW-1 on her neck with your hands you accused No.2 slapped CW-1 on her cheek and you accused No.1 scratched CW-1 with your hands on her chest and caused internal injury and thereby you accused have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code and within my cognizance.

Finally, that on above said date, time and place, in furtherance of common intention, you accused No.1 to 4 wrongfully restrained the movement of CW-1 from moving in a direction with an intention to commit certain offences and thereby you accused have committed an offence punishable U/Sec.341 R/w Sec.34 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried on the said charge.
