SUBSTANCE OF ACCUSATION

It is alleged by the prosecution that, on 18.11.2021 at 07.50 pm on the public road of T.Narasipura-Biligerehundi, near Hullahalli Naala, Hunasuru, T.Narasipura Taluk within the limits of T.Narasipura Police Station, you accused being the driver of Tractor bearing Reg.No.KA-55-T-637 and Trailer No.KA-55-T-638 drove the same in rash and negligent manner, so as to endanger human life and personal safety of others and thereby you accused have committed an offence punishable U/Sec.279 of Indian Penal within my cognizance.

It is further alleged by the prosecution that, on the above said date, time and place, you accused by driving the above said Vehicle in the above said manner and suddenly stopped the said vehicle on the middle of the road without giving any signal light, by that time a motorcycle bearing Reg.No.KA-55-EA-3146 dashed to your vehicle and caused the accident. Due to the said accident CW-2 who was the pillion rider of the said motorcycle fell down and sustained simple injuries and thereby you accused have committed an offence punishable U/Sec.337 of I.P.C. within my cognizance.

It is further alleged by prosecution that, on the above said date, time and place during the course of same transaction you accused being the driver of above mentioned offending vehicle, drove the same in a high speed and in a rash and negligent manner and suddenly stopped the said vehicle on the middle of the road without giving any signal light, by that time a motorcycle bearing Reg.No.KA-55-EA-3146 dashed to your vehicle and caused accident. Due to the said M.Rajashekhara who was the rider of the said motorcycle fell down and sustained grievous injuries ultimately he succumbed to those injuries and thereby you accused have committed an offence of culpable homicide not amounting to murder punishable U/Sec.304(A) of Indian Penal Code and within my cognizance.

It is further alleged by the prosecution that, on the above said date, time and place, you accused being the driver of above mentioned offending vehicle drove the same rash and negligent manner and caused accident, after the accident you accused went away from the spot without giving medical aid to the injured victims of this crime so also without intimating about factum of incident to the nearest police station and thereby you accused has committed an offence punishable U/Sec.187 of I.M.V. Act within my cognizance.

And I hereby direct that you be tried by this court on the said Plea.
