C H A R G E

I, **Mahavir.M.Karennavar**, Senior Civil Judge & JMFC,
T.Narasipura, do hereby charge you, as follows;

Firstly, that on 23.06.2021 at 08.30 pm, in front of old
Dr.B.R.Ambedkar Bhavana, Chidaravalli village, T.Narasipura

Taluk, within the limits of T.Narasipura Police Station, in furtherance of common intention with old hatred, you accused Nos.1 to 4 picked-up quarrel with CW-1 and you accused No.2 rotated the hands of CW-1 and you accused No.3 kicked CW-1 with your legs and caused simple injuries to him and thereby you accused have committed an offence punishable U/Sec.323 R/w Sec.34 of Indian Penal Code and within my cognizance.

Secondly, that on above said date, time and place, in furtherance of common intention with old hatred, you accused No.1 assaulted CW-1 on his left side of the head with a stick, which is used as a weapon of offence likely to cause death and caused simple injury and thereby you accused have committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code and within my cognizance.

Thirdly, that on the above said date, time and place, in furtherance of common intention with old hatred, you accused Nos.1 to 4 wrongfully restrained the movement of CW-1 from moving in a direction with an intention to commit certain offences and thereby you accused have committed an offence punishable U/Sec.341 R/w Sec.34 of Indian Penal Code and within my cognizance.

Fourthly, that on above said date, time and place, in furtherance of common intention with old hatred, you accused Nos.1 to 4 abused CW-1 in filthy language saying and thereby

gave provocation to him intending or knowing it likely that such provocation will cause him to break the public peace or to commit any other offence and thereby you accused have committed an offence punishable U/Sec.504 R/w Sec.34 of Indian Penal Code and within my cognizance.

Fifthly, that on above said date, time and place, in furtherance of common intention with old hatred, you accused Nos.1 to 4 criminally intimidated CW-1 by threatening to take away his life, so as to cause alarm in his mind and thereby you accused have committed an offence punishable U/Sec.506 R/w sec.34 of Indian Penal Code and within my cognizance.

Finally, that on above said date, time and place, in furtherance of common intention you accused No.4 abetted the other accused to commit the offence and also to act criminally against the CW-1 and thereby you accused have committed an offence punishable U/Sec.114 R/w Sec.34 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried on the said charge.
