ORDERS

*This is the petition filed by the petitioners U/Sec.13(3) of
Registration of Births and Deaths Act.*

The petition averments is as under:

2. The mother of petitioner No.1 and 2 by name Savithramma W/o Late D.Kalegowda, was expired on 13.09.1980 at Kodagahalli Village, Bannur Hobli, T.Narasipura Taluk. The petitioners had informed the date of death of deceased Savithramma W/o Late D.Kalegowda, to the respondent orally, but they had not registered the same in the register maintained by them. That now, the petitioners required the death certificate of deceased Savithramma W/o Late D.Kalegowda, in order to produce before revenue authorities to change katha and other documents in their favour and to obtain other benefits. They had filed application before the respondent for issuance of the death certificate of Savithramma W/o Late D.Kalegowda, but the respondent office has issued non-availability certificate. Hence, this application.

3. In spite of receipt of notice, the respondent did not appear before this Court. Hence, respondent placed ex-parte.

4. Heard arguments of learned counsel for the petitioners and perused the materials available on record.

5. The following points arise for the consideration of this Court:

POINT No.1 : Whether the petitioners have made out sufficient grounds to allow this petition?

POINT No.2 : What order?

6. The answers of this Court to the above said points are as under:

REASONS

POINT NO.1:

7. That mother of petitioner No.1 and 2 by name Savithramma W/o Late D.Kalegowda, was expired on 13.09.1980 at Kodagahalli Village, Bannur Hobli, T.Narasipura Taluk. But, the said fact is not registered in the respondent's office. The 1st petitioner has got examined himself as P.W.1 and got marked 6 documents as Ex.P.1 to Ex.P.6. Ex.P.1 is the non-availability certificate which discloses that the date of death of Savithramma W/o Late D.Kalegowda, is not registered in the register maintained by the respondent. Exs.P.2 and 3 are paper publications calling upon any objections to obtain the death certificate of Savithramma W/o Late D.Kalegowda,. Ex.P.4 and 5 are notarized copies of Aadhar cards of petitioners. Ex.P.6 is certificate of Genealogical tree of family of deceased Savithramma W/o Late D.Kalegowda, wherein it discloses that the deceased Savithramma W/o Late D.Kalegowda, is mother of petitioner No.1 and 2. In spite of receipt of notice, respondent did not appear before the Court. Evidence of petitioners is not challenged by the respondent. Evidence of petitioners is corroborated by the documentary evidence. Hence, there is no reason to disbelieve the evidence of petitioners. As such, this Court is of the opinion that the petitioners have made out grounds to allow this petition and accordingly, **this Court answers point No.1 in the Affirmative.**

POINT No.2:

8. In the result, this Court proceeds to pass the following:

ORDER

Petition filed U/Sec.13(3) of The Registration of Births and Deaths Act is hereby allowed.

*The respondent is hereby directed to enter the date of death of **Savithramma W/o Late D.Kalegowda**, resident of Kodagahalli Village, Bannur Hobli, T.Narasipura Taluk as **13.09.1980** in the register maintained by them after collecting late fee and issue death certificate accordingly.*
