Claim: The plaintiffs pray this court be pleased to pass the judgment and decree against the first defendant for the relief's as follows:

- a) For permanent injunction restraining the defendants, his successors, their men, agents or any body acting on behalf of them from put up any illegal construction by encroaching the existed Galli and thereby interfering with peaceful possession and enjoyment of the plaintiffs over schedule property.
- b) For mandatory injunction directing the defendants to remove the obstruction i.e., water Tap and stair case over the Galli existed between the houses of plaintiffs and defendants.
- c) Grant cost of the suit and such other relief as deems fit by this court in the circumstances of the case, in the interest of justice and equity.

This suit coming on this the 2nd day of June 2026 for final disposal before **Smt. Niveditha N., B.A.L., LL.M., I Addl. Civil Judge and JMFC. T. Narasipura**, in the presence of Sri. K.S. Shambhulingaswamy, Advocate for the plaintiffs and Sri. K.G. Palaksha Murthy, Advocate for defendants.

By pronouncing the judgment it is ordered and decreed that the suit of the plaintiffs is decreed with costs.

Further it is ordered and decreed that the defendants, their agents, servants or any other persons acting under them are hereby restrained permanently from putting up any illegal construction by encroaching the Galli and further restrained them from interfering with the peaceful possession and enjoyment of the suit schedule property of the plaintiffs.

Further it is ordered and directed that the defendants to remove water tap and stair case which was constructed over the Galli within 3 months from the date of this order.
