Claim:- The plaintiff prays the court to pass a judgment and decree in favor of plaintiff and against the defendant as follows:

a) Declare that the plaintiff is the owner of A Schedule property.

b) For mandatory injunction directing the defendant of demolish the illegal construction put up in B schedule property deliver possession of 2 feet. If the defendant failed to demolish the construction the same may be ordered to be demolish through the court commissioner at the costs and expenses of the defendant.

c) For the relief of permanent injunction restraining the defendants, servants, agents or any other person acting under the defendants interfering with plaintiff peaceful possession, enjoyment of the property or trespass into the schedule property and there by disposing plaintiff from the schedule property.

d) Award cost of the suit and further grant such other reliefs as necessary in the circumstances of the case.

This suit is coming on 1st day of December 2021 for final disposal before **Sri. Prashantha G.C.**, B.A.L., LL.M., Civil Judge and JMFC., T.Narasipura, in the presence of **Sri. B.M.Nagabhushanamurthy**, advocate for the plaintiff and **Sri. A.L. Shabbirahmed**, advocate for the defendant.

By pronouncing the judgment it is ordered and decreed that the suit of the plaintiff is hereby partly decreed.

It is further decreed and hereby declared that the plaintiff is the absolute owner in respect of the suit 'A' schedule property.

It is further decreed and hereby directed to the defendant to demolish East to West 10 and North to South 7 feet from the northern side of suit 'A' schedule property within 60 days from the date of the order which is shown as suit 'B' property. Failing which the plaintiff with due process of law shall demolish the illegal construction in the aforesaid measurement on his own cost.

It is further ordered and decreed the the defendant, his servants, agents or any other person acting under her is hereby directed not to interfere to the suit 'A' and 'B' property.

The parties shall bear their own cost.
