

By pronouncing the judgment it is ordered and decreed that the suit of the plaintiff is hereby decreed with cost.

Further it is ordered and decreed that by way of mandatory injunction the defendants No.1 and 2 are directed to remove the Kalli fence and compound wall, toilet and bathroom elevated in the "B" schedule 11 feet road at their own cost.

Further it is ordered and decreed that the defendants and their servants, henchmen, their agents and their legal representatives or anybody acting on behalf of them are restrained from putting up any construction over the "B" schedule property.

Further it is ordered and decreed that the defendants do also pay to plaintiff a sum of Rs.1150/- as costs incurred in the suit.
