d) Award cost of the suit and further grant such other relief/s as the court deem fit in the circumstances of the case in the interest of justice and equity.

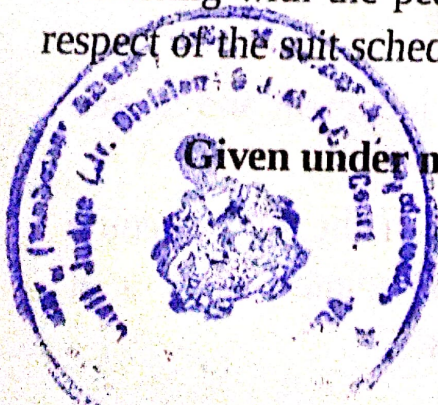
