This Crl. MC came up for hearing on 17.10.2022 and the court on the same day passed the following:-

ORDER

1. This is an application filed by the petitioners u/s.438 of Cr.PC for anticipatory bail.
2. **Gist of the averments in the petition is as follows:-**It is apprehended that the police is trying to arrest the petitioners in connection with a false complaint. The petitioners are ready to abide by any conditions and they may be enlarged on bail.
3. A report is filed by the Nemom Police Station, Thiruvananthapuram that no case is registered against the petitioner.
4. Both sides are heard.
5. Based on the submissions by the learned Public Prosecutor and after considering the police report, it deems just and proper to record the contents in the police report for disposing this application.

6. Hence, this application is disposed by recording the contents in the police report and submission of the learned Public Prosecutor that the petitioners are not arrayed as an accused in any case and the Station House Officer is also directed that the petitioners shall not be insisted to appear before the police station otherwise than under due process of law u/s.41A of Cr.PC.
