

ORDER BELOW EXH. 01 IN O.M.A. No. 320 of 2022

This an application seeking permission to enter the name of applicants deceased grand-mother in the Register of Birth and death.

2. It is submitted that, grand-mother of applicant namely Parvatibai Shankar Adhikari was died on 20/08/1985 at Sarlambe, Tal. Shahapur, Dist. Thane. Applicant or any member from his family have not taken the entry of death of the name of deceased at anywhere. Hence, applicant came with present application seeking relief that direction as to entry of name of deceased Parvatibai Shankar Adhikari in the register of death, be given to Registrar of Birth and death.

3. In response to application, notice was issued to non-applicant. Non-applicant file his say at Exh. 12 and thereby raised no objection to the application.

4. Further more, paper proclamation calling objection was issued, the copy of which is produced on record vide Exh.11. No one has raised objection for issuance of death certificate in the name of grand-mother of applicant. Furthermore, in support of the claim applicant has filed certificate issued by Registrar birth and death Grampanchayat Sarlambe (Exh. 3/2) and verified copy of Aadhaar card of applicant (Exh.3/1).

5. In support of the application, applicant himself deposed vide Exh. 06 and reproduced the facts mentioned in the application. In addition to that applicant also relied upon the evidence of Martand Bhau Adhikari (Exh. 07) and deposed that deceased Parvatibai

Shankar Adhikari was died on 20/08/1985 at Sarlambe, Tal. Shahapur.

6. On perusal of application, affidavits and documents produced on record, it can be ascertained that there is no entry as to death of applicant's grand-mother in the register of birth and death. On going through the affidavits and documents produced on record, it transpires that grand-mother of applicant was died on 20/08/1985 at Sarlambe, Tal. Shahapur, Dist. Thane. Hence, at this stage it is just and necessary to give directions to that effect. In the result, I pass following order.

ORDER

1. Grampanchayat Sarlambe, Tal. Shahapur is directed to enter the name of grand-mother of applicant namely **Parvatibai Shankar Adhikari, who was died on 20/08/1985** at Sarlambe, Tal. Shahapur, Dist. Thane in the Register of Death maintained at Grampanchayat Sarlambe, Tal. Shahapur.
2. Grampanchayat Sarlambe, Tal. Shahapur is directed to issue death certificate after entry of name of grand-mother of applicant namely Parvatibai Shankar Adhikari, in the death register on depositing appropriate fees.
3. Application is disposed off accordingly.
