ORDER

1. The above named accused has been sent up to face trial for the offences punishable U/s 379 B, 411 of Indian Penal Code, by officer in charge of Police Station Navi Baradari, Jalandhar.
2. The criminal justice system, in the present case, was set into motion on the statement of Kuldeep Kaur, Senior Assistant Office AIG, R/o H.No.207, Village Ladoi near St.Soldier School, Bhogpur, Distt. Jalandhar, who stated therein that she is resident of above said address and

she is working as Senior Assistant in Office of AIG, Zonal, Jalandhar. She stated that on dated 16.01.2019, at about 4:00 PM, she was going to buy medicine from Medical store, Ladowali Road and when she reached near to Poltechnical College, then a young clean shaven person, upon Splender Motorcycle, came near to her from backside and she slow down her activa bearing no.PB08-DL-2825. In the meanwhile, the said person snatched her purse of black colour and ran away. She tried to chase him but due to traffic, the said person ran away alongwith her purse containing Rs.27,000/-, RC of her activa bearing no.PB08-DL-2825, her identity card, PAN card, Driving licence, ATM of HDFC Bank, ATM of her husband of Capital Bank and two mobile phones of Samsung and Jio Company.

3. After recording the statement of complainant by ASI Hardial Singh, conducted police proceedings, on the basis of which FIR was registered. Rough site plan was prepared. During the investigation, accused was arrested. Statement of witnesses were recorded. After completion of investigation, challan was presented in the Court.

4. On presentation of challan, copies thereof and other documents relied upon by the prosecution, were supplied to the accused as required U/s 207 CrPC.

5. I have heard the ld. APP for the state and Ld. Counsel for the accused and have gone through the file.

6. From the report U/s 173 CrPC and the statement of witnesses and other annexed documents, it appears that accused has prima facie

committed an offence punishable U/s 379 B and 411 of IPC. The offence U/s 379 B of Indian Penal Code is exclusively triable by the Court of Sessions. Therefore, the case is committed to the court of Sessions for trial for 06.06.2019. Accused Manni Kumar in custody be produced before the Ld. Sessions Judge Jalandhar on 06.06.2019 at 10 A.M. sharp. The office of District Attorney is apprised of the contents of this order through APP. The Ahlmad/ Reader are directed to complete the file in all respects and then Ahlmad shall send the file well in advance to the Court of Ld. Sessions Judge, Jalandhar for 06.06.2019.

7. This order has been notified to the public prosecutor.
