as follows:-

Firstly, on 11.05.2025, at about 11.30 pm.,
in the night, the CW's.1 & 4 to 6 after dining, the
CW.1/complainant having been to remove his

vehicle from the road in-front of Mareppa Apartment near Laxman lay-out in Raichur city, within the limits of Netaji-Nagar PS, you the accused No's.1 to 3 in-furtherance of common intention, raised the squabble with CW.1/complainant and you the accused No.1 came on a TVS Co., Scooty bearing No.KA-36/HE-0994 & unlawfully restrained the CW.1/complainant and thereby, you the accused-persons committed the offence punishable **U/Sec.126(2) R/w Sec.3(5) of BNS-2023 and within the cognizance of this Special court of Sessions.**

Secondly, on the above said date, time & place, you the accused No's.1 to 3 in-furtherance of common intention, raised the squabble with CW.1 & forced him to express/shout the slogan as "pakistan zindabad", warning not to shout the slogan as "India zindabad" for which, the CW's.1 & 4 to 6 resisted, wherefore, you the accused No's.1 to 3 abused them in filthy language intentionally with an intent to provoke them to

break the public peace and thereby, you the accused-persons committed the offence punishable **U/Sec.352 R/w Sec.3(5) of BNS-2023 and within the cognizance of this Special court of Sessions.**

Thirdly, on the above said date, time & place, you the accused No's.1 to 3 in-furtherance of common intention, raised the squabble with CW's.1 & 4 to 6 & you the accused No.1 assaulted on the face & back of CW.5 with your hands, & you the accused No.2 assaulted the CW's.4 & 6 with your hands and caused the simple injuries and thereby, you the accused-persons committed the offence punishable **U/Sec.115(2) R/w Sec.3(5) of BNS-2023 and within the cognizance of this Special court of Sessions.**

Fourthly, on the above said date, time and place, you the accused No's.1 to 3 in furtherance of common intention, raised the squabble with the CW's.1, 4 to 6 & you the accused No's.2 & 3 assaulted with the stones on the head, left-eye,

stomach, near left-ear, shoulder & left-knee of the CW.1 & you the accused No.1 assaulted on the chest, right-shoulder, head & face of the CW.5 with a stone and caused the simple injuries and thereby, you the accused-persons committed the offence punishable **U/Sec.118(1) R/w Sec.3(5) of BNS-2023 and within the cognizance of this Special court of Sessions.**

Fifthly, on the above said date, time and place, you the accused No's.1 to 3 in furtherance of common intention, raised the squabble with the CW's.1, 4 to 6 & you the accused No.2 with an intention to commit the murder of CW.4 assaulted with a rough-stone on the head of the CW.4 & you the accused No.1 assaulted the CW.1 on his stomach with a sharp iron-rod and caused the injuries and thereby, you the accused-persons committed the offence punishable **U/Sec.307 R/w Sec.3(5) of BNS-2023 and within the cognizance of this Special court of Sessions.**

Sixthly, on the above said date, time and place, you the accused No's.1 to 3 in furtherance of common intention, raised the squabble with the CW's.1, 4 to 6 & criminally intimidated by threatening to their lives with dire-consequences and thereby, you the accused-persons committed the offence punishable **U/Sec.351(2) R/w Sec.3(5) of BNS-2023 and within the cognizance of this Special court of Sessions.**

Seventhly, on the above said date, time and place, you the accused No's.1 to 3 knowing fully-well that, CW.1/complainant belonged to Hindu-Madiga sub-caste coming within the category of the Scheduled-Castes, criminally intimidated by threatening to his life with dire-consequences and thereby, you the accused-persons committed the offence punishable **U/Sec.3(1)(r) of SC&ST(PA) Amendment Act-2015 and within the cognizance of this Special court of Sessions.**

Eighthly, on the above said date, time and place, you the accused No's.1 to 3 knowing fully-

well that, CW.1/complainant belonged to Hindu-Madiga sub-caste coming within the category of the Scheduled-Castes, abused them in filthy language, in the name of their sub-caste, intentionally with an intent to insult, degrade & humiliate them in the public view and caused the atrocity against them and thereby, you the accused-persons committed the offence punishable **U/Sec.3(1)(s) of SC&ST(PA) Amendment Act-2015 and within the cognizance of this Special court of Sessions.**

Lastly, on the above said date, time and place, you the accused No's.1 to 3 knowing fully-well that, CW.1/complainant belonged to Hindu-Madiga sub-caste coming within the category of the Scheduled-Castes, committed the offences against them punishable with imprisonment & fine under the BNS-2023, as specified in the schedule of the Act and thereby, you the accused-persons committed the offence punishable **U/Sec.3(2)(va) of SC&ST(PA)**

Amendment Act, 2015 and within the cognizance of this Special court of Sessions.

And I hereby direct that you be tried on the above said charge/s.
