charge you:-

Raichur.
- 04 Bheemanna S/o Tayappa, Age:

Y.Mallapur village, Tq and Dist
Raichur.
- 05 Tayappa @ Tayanna S/o
Nallareddy, Age: 25 years,
Occ: Farmer, R/o Y.Mallapur
village, Tq and Dist Raichur.

as follows:-

Firstly, on 16.11.2024, at about 10.00 am., in the morning, the CW's.1 & 6 having passed through the land of you the accused-persons to reach their land bearing Sy.No.117 and engaged in their land-work ; wherefore, you the accused No's.1 & 4 went to the land of CW's.1 & 6 and questioned as to why they passed through your land & abused them in filthy language and thereafter, in the evening, at about 4.30 pm., again, while the CW's.1, 6 & 7 were passing through the land of you the accused-persons to bring the cotton from their land, again, you the accused No's.1 to 5 in prosecution with common object formed an unlawful assembly, raised the squabble with them & abused them in filthy language intentionally with an intent to provoke them to break the public peace and thereby, you the accused-persons committed the offence punishable **U/Sec.352 R/w Sec.190 of BNS-2023 and within the cognizance of this Special court of Sessions.**

Secondly, on the above said date, time and place, you the accused No's.1 to 5 along-with the CCL by name Parashuram S/o Nallareddy, in-prosecution with common object, formed an unlawful assembly, with an intention to commit rioting, by holding the deadly weapons such as, sticks & raised the squabble with the CW's.1, 6 & 7 and thereby, you the accused-persons committed the offences punishable **U/Secs.189(2), 191(2) & 191(3) R/w Sec.190 of BNS-2023 and within the cognizance of this Special court of Sessions.**

Thirdly, on the above said date, time and place, you the accused No's.1 to 5 along-with the CCL by name Parashuram S/o Nallareddy, in-prosecution with common object, formed an unlawful assembly, & raised the squabble with the CW's.1, 4, 6 & 7 and you the accused No's.1 & 4 put the towel in the mouth of CW.6 and assaulted him with your hands and you the accused No's.1 & 4 assaulted the CW.6 with your hands on the chest & back and caused the simple

injuries and thereby, you the accused-persons committed the offence punishable **U/Sec.115(2) R/w Sec.190 of BNS-2023 and within the cognizance of this Special court of Sessions.**

Fourthly, on the above said date, time and place, you the accused No's.1 to 5 along-with the CCL by name Parashuram S/o Nallareddy, in-prosecution with common object, formed an unlawful assembly & unlawfully restrained the CW.7 from proceeding further and thereby, you the accused-persons committed the offence punishable **U/Sec.126(2) R/w Sec.190 of BNS-2023 and within the cognizance of this Special court of Sessions.**

Fifthly, on the above said date, time and place, you the accused No's.1 to 5 along-with the CCL by name Parashuram S/o Nallareddy, in-prosecution with common object, formed an unlawful assembly, & raised the squabble with the CW's.1, 4, 6 & 7 & you the accused No.1 assaulted with the stick on his head and caused the bleeding injury, & you the accused No's.2 & 3

assaulted with the sticks on the body of the CW.6 and caused the simple injuries and thereby, you the accused-persons committed the offence punishable **U/Sec.118(1) R/w Sec.190 of BNS-2023 and within the cognizance of this Special court of Sessions.**

Sixthly, on the above said date, time and place, you the accused No's.1 to 5 along-with the CCL by name Parashuram S/o Nallareddy, in-prosecution with common object, formed an unlawful assembly, & raised the squabble with the CW's.1, 4, 6 & 7, you the accused No.5 dragged the hand of CW.1/complainant and you the accused No's.1 & 4 dragged the saree & blouse of CW.1/complainant and outraged her modesty and thereby, you the accused-persons committed the offence punishable **U/Sec.74 R/w Sec.190 of BNS-2023 and within the cognizance of this Special court of Sessions.**

Seventhly, you the accused No's.1 to 5 along-with the CCL by name Parashuram S/o Nallareddy, in-prosecution with common object,

formed an unlawful assembly, & raised the squabble with the CW's.1, 4, 6 & 7 & criminally intimidated by threatening to their lives with dire-consequences and thereby, you the accused-persons committed the offence punishable **U/Sec.351(2) R/w Sec.190 of BNS-2023 and within the cognizance of this Special court of Sessions.**

Eighthly, on the above said date, time and place, you the accused No's.1 to 5 knowing fully-well that, the CW's.1, 4, 6 & 7 belonged to Hindu-Bhovi/Waddar sub-caste coming within the category of the Scheduled-Castes, criminally intimidated by threatening to their lives with dire-consequences and thereby, you the accused-persons committed the offence punishable **U/Sec.3(1)(r) of SC&ST(PA) Amendment Act-2015 and within the cognizance of this Special court of Sessions.**

Ninethly, on the above said date, time and place, you the accused No's.1 to 5 knowing fully-well that, the CW's.1, 4, 6 & 7 belonged to

Hindu-Bhovi/Waddar sub-caste coming within the category of the Scheduled-Castes, abused them in filthy language, in the name of their sub-caste, intentionally with an intent to insult, degrade & humiliate them in the public view and caused the atrocity against them and thereby, you the accused-persons committed the offence punishable **U/Sec.3(1)(s) of SC&ST(PA) Amendment Act-2015 and within the cognizance of this Special court of Sessions.**

Tenthly, on the above said date, time and place, you the accused No's.1, 4 & 5 knowing fully-well that, the CW.1/complainant belonged to Hindu-Bhovi/Waddar sub-caste coming within the category of the Scheduled-Castes, touched her body in the sexual nature and thereby, you the accused No's.1, 4 & 5 committed the offence punishable **U/Sec.3(1)(w-i) of SC&ST(PA) Amendment Act-2015 and within the cognizance of this Special court of Sessions.**

Lastly, on the above said date, time and place, you the accused No's.1 to 5 knowing fully-

well that, the CW's.1, 4, 6 & 7 belonged to Hindu-Bhovi/Waddar sub-caste coming within the category of the Scheduled-Castes, committed the offences against them punishable with the imprisonment & fine under the BNS-2023, as specified in the schedule of the Act and thereby, you the accused-persons committed the offence punishable **U/Sec.3(2)(va) of SC&ST(PA) Amendment Act, 2015 and within the cognizance of this Special court of Sessions.**

And I hereby direct that you be tried on the above said charge/s.
