as follows:-

Firstly, on 02.03.2024, at about 6.30 am., in the morning, while the CW's.2 & 3 were proceeding towards their land through Samudra- Mundaragi main-road, you the accused unlawfully restrained them from proceeding further and questioned them, as to why they objected his family members to go to answer the nature-call near the bushes existing in the land of CW.1/complainant, situated at Pandiyana village and thereby, you the accused committed the offence punishable **U/Sec.341 of IPC.**

Secondly, on above said date, time and place, you the accused raised the squabble with the CW's.2 & 3, & assaulted with your hands and caused the simple hurt and thereby, you the accused committed the offence punishable **U/Sec.323 of IPC.**

Thirdly, on above said date, time and place, you the accused raised the squabble with the CW's.2 & 3, & abused them in filthy language intentionally with an intent to provoke them to break the public peace and thereby, you the accused committed the offence punishable **U/Sec.504 of IPC.**

Fourthly, on above said date, time and place, you the accused raised the squabble with the CW's.2 & 3, & criminally intimidated by threatening to their lives with dire-consequences and thereby, you the accused committed the offence punishable **U/Sec.506 of IPC.**

Fifthly, on above said date, time and place, you the accused knowing fully-well that, the said CW's.2 & 3 belonged to Hindu – Bedara sub-caste, coming within the category of Scheduled Tribes, criminally intimidated by threatening to their lives with dire-consequences and thereby, you the accused committed

the offence punishable **U/Sec.3(1)(r) of SC&ST(PA) Amendment Act-2015.**

Sixthly, on above said date, time and place, you the accused knowing fully-well that, the said CW's.2 & 3 belonged to Hindu – Bedara sub-caste, coming within the category of Scheduled Tribes, abused them in filthy language in the name of their sub-caste intentionally with an intention to insult and degrade in the public view and caused the atrocity against them and thereby, you the accused committed the offence punishable **U/Sec.3(1)(s) of SC&ST(PA) Amendment Act-2015.**

Lastly, on above said date, time and place, you the accused knowing fully-well that, the said CW's.2 & 3 belonged to Hindu – Bedara sub-caste, coming within the category of Scheduled Tribes, you the accused committed the offences against CW's.2 & 3 punishable under the IPC and thereby, you the accused committed the offence punishable **U/Sec.3(2)(va) of SC&ST(PA) Amendment Act-2015.**
