Raichur, do hereby charge you:-

- 01 Umesh S/o Mallikarjun, Age: 27
years, Occ: Driver, R/o LBS
Nagar, Raichur.
- 02 Kamil S/o Syed Pash, Age: 21
years, Occ: Unemployed, R/o
LBS Nagar, Raichur.

as follows:-

Firstly, on 03.03.2020, at about 9.00 pm., in the night, while the CW.1/complainant was smoking the cigarette near the flag plat-form near Ganesh temple at LBS -Nagar within the limits of Market-Yard PS, Raichur, you the accused No's.1 & 2 in-furtherance of common intention, raised the squabble with the CW.1/complainant, questioning as to why he had come to your area and assaulted with your hands & kicked with your legs and caused the simple injuries and thereby,

you the accused-persons committed the offence punishable **U/Sec.323 R/w Sec.34 of IPC and within the cognizance of this court of Sessions.**

Secondly, on the above said date, time & place, you the accused No's.1 & 2 in-furtherance of common intention, raised the squabble with the CW.1/complainant and you the accused No.1 assaulted on the left-ribs of the CW.1 with a knife, you the accused No.2 assaulted with a knife on the right-ribs, neck, back & left-elbow and caused the bleeding injuries, with an intention to commit his murder and thereby, you the accused-persons committed the offences punishable **U/Sec.324 & 307 R/w Sec.149 of IPC and within the cognizance of this court of Sessions.**

Thirdly, on the above said date, time & place, you the accused No's.1 & 2 in-furtherance of common intention, raised the squabble with the CW.1/complainant & abused him in filthy language intentionally with an intent to provoke him to break the public peace and thereby, you

the accused-persons committed the offence punishable **U/Sec.504 R/w Sec.34 of IPC and within the cognizance of this court of Sessions.**

Lastly, on the above said date, time & place, you the accused No's.1 & 2 in-furtherance of common intention, raised the squabble with the CW.1/complainant & criminally intimidated by threatening to his life with dire-consequences and thereby, you the accused-persons committed the offence punishable **U/Sec.506 R/w Sec.34 of IPC and within the cognizance of this court of Sessions.**

And I hereby direct that you be tried on the above said charge/s.
