as follows:-

Firstly, on 19.06.2025, at about 3.30 pm., in the afternoon, while the CW.1/complainant along-with CW's.2 to 10 were sowing the cotton-seeds in the land bearing Sy.No.81/4, situated at Khanapur village, within the limits of Gabbur PS, you the accused No's.1 to 9, in-prosecution with common object formed an unlawful assembly, with an intention to commit rioting, by holding deadly-weapons such as, sticks and thereby, you the accused-persons committed the offences punishable **U/Secs.189(2), 191(2) & 191(3) R/w Sec.190 of BNS-2023 and within the cognizance of this Special court of Sessions.**

Secondly, on the above said date, time and place, you the accused No's.1 to 9 in-prosecution

with common object, formed an unlawful assembly & raised the squabble with the CW's.1 to 10 and unlawfully trespassed-into the said land and thereby, you the accused-persons committed the offence punishable **U/Sec.329(3) R/w Sec.190 of BNS-2023 and within the cognizance of this Special court of Sessions.**

Thirdly, on the above said date, time and place, you the accused No's.1 to 9 in-prosecution with common object, formed an unlawful assembly & raised the squabble with the CW's.1 to 10 and you the accused No.2 kicked to the stomach of CW.1/complainant and you the accused No's.3 to 9 assaulted the CW.1/complainant with your hands and caused the simple injuries and thereby, you the accused-persons committed the offence punishable **U/Sec.115(2) R/w Sec.190 of BNS-2023 and within the cognizance of this Special court of Sessions.**

Fourthly, on the above said date, time and place, you the accused No's.1 to 9 in-prosecution with common object, formed an unlawful

assembly and raised the squabble with the CW's.1 to 10 and you the accused No.2 assaulted with a stick on the body of CW.1/complainant and caused the simple injury and thereby, you the accused-persons committed the offence punishable **U/Sec.118(1) R/w Sec.190 of BNS-2023 and within the cognizance of this Special court of Sessions.**

Fifthly, on the above said date, time and place, you the accused No's.1 to 9 in-prosecution with common object, formed an unlawful assembly and raised the squabble with the CW's.1 to 10 & abused them in filthy language intentionally with an intent to provoke them to break the public peace and thereby, you the accused-persons committed the offence punishable **U/Sec.352 R/w Sec.190 of BNS-2023 and within the cognizance of this Special court of Sessions.**

Sixthly, on the above said date, time and place, you the accused No's.1 to 9 in-prosecution with common object, formed an unlawful assembly and raised the squabble with the

CW's.1 to 10 & criminally intimidated by threatening to their lives with dire-consequences and thereby, you the accused-persons committed the offence punishable **U/Sec.351(2) R/w Sec.190 of BNS-2023 and within the cognizance of this Special court of Sessions.**

Seventhly, on the above said date, time and place, you the accused No's.1 to 9 knowing fully-well that, CW's.1 to 10 belonged to Hindu-Nayak sub-caste coming within the category of Scheduled-Tribes, criminally intimidated by threatening to their lives with dire-consequences and thereby, you the accused-persons committed the offence punishable **U/Sec.3(1)(r) of SC&ST(PA) Amendment Act-2015 and within the cognizance of this Special court of Sessions.**

Eighthly, on the above said date, time and place, you the accused No's.1 to 9 knowing fully-well that, CW's.1 to 10 belonged to Hindu-Nayak sub-caste coming within the category of Scheduled-Tribes, abused them in filthy language, in the name of their sub-caste, intentionally with

an intent to insult, degrade & humiliate them in the public view and caused the atrocity against them and thereby, you the accused-persons committed the offence punishable **U/Sec.3(1)(s) of SC&ST(PA) Amendment Act-2015 and within the cognizance of this Special court of Sessions.**

Lastly, on the above said date, time and place, you the accused No's.1 to 9 knowing fully-well that, CW's.1 to 10 belonged to Hindu-Nayak sub-caste coming within the category of Scheduled-Tribes, & committed the offences against them punishable with imprisonment & fine under the BNS-2023, as specified in the schedule of the Act and thereby, you the accused-persons committed the offences punishable **U/Sec.3(2)(va) of SC&ST(PA) Amendment Act, 2015 and within the cognizance of this Special court of Sessions.**

And I hereby direct that you be tried on the above said charge/s.
