- 01 Yankappa @ Yankanna S/o Kyasarayayya @ Kasharamayya, Age: 71 years, Occ: Farmer, Caste: Hindu, R/o Jambaladinni Village, Tq and Dist: Raichur.
- 02 Bheemesh S/o Yankappa @ Yankanna, Age: 31 years, Occ: Farmer, Caste: Hindu, R/o Jambaladinni Village, Tq and Dist: Raichur.
- 03 Nagaraj S/o Yankappa @ Yankanna, Age: 30 years, Occ: Farmer, Caste: Hindu, R/o Jambaladinni Village, Tq and Dist: Raichur.
- 04 Narasimhalu @ Balayola Narasimhalu S/o Hanumanthappa @ Hanumantha, Age: 54 years, Occ: Farmer, Caste: Hindu, R/o Jambaladinni Village, Tq and Dist: Raichur.

as follows:-

Firstly, on 28.08.2024, at about 9.30 pm.,
in the night, the CW's.1 & 4 to 6 having been to
the road near the house of the accused persons
to enquire as to why you the accused persons
had let the water to their land, you the accused
No's.1 to 7 in prosecution with common object
formed an unlawful assembly with an intention to
commit rioting against them by holding the
deadly weapons such as, sticks, iron-rods & etc.,
and raised the squabble with them and thereby,
committed the offences punishable
**U/Secs.189(2), 191(2), 191(3) R/w Sec.190
of BNS-2023.**

Secondly, on the above said date, time & place, you the accused No's.1 to 7 in prosecution with common object formed an unlawful assembly and raised the squabble with the CW's.1 & 4 to 6 and abused them in filthy language intentionally with an intent to provoke them to break the public peace and thereby, committed the offence punishable **U/Sec.352 R/w Sec. 190 of BNS-2023.**

Thirdly, on the above said date, time & place, you the accused No's.1 to 7 in prosecution with common object formed an unlawful assembly and raised the squabble with the CW's.1 & 4 to 6 and you the accused No's.4 to 7 assaulted the CW's.1, 4 & 5 with your hands and caused the simple injuries and thereby, committed the offence punishable **U/Sec.115(2) R/w Sec. 190 of BNS-2023.**

Fourthly, on the above said date, time & place, you the accused No's.1 to 7 in prosecution with common object formed an unlawful assembly and raised the squabble with the

CW's.1 & 4 to 6 and you the accused No.1 assaulted the CW.4 with an iron-rod on his head and caused the bleeding injury, you the accused No.2 assaulted with a stick on the back and stomach of CW.1, you the accused No.3 assaulted on the head & hands of the CW.5 with a stick and, caused the bleeding injuries and there committed the offence punishable **U/Sec.118(1) R/w Sec.190 of BNS-2023.**

Fifthly, on above said date, time and place, you accused No's.1 to 7 knowing fully-well that, CW's.1 & 4 to 6 belonged to Hindu-Madiga sub-caste, coming within the category of Scheduled Caste, criminally intimidated by threatening to their lives with dire-consequences and thereby, committed the offence punishable **U/Sec.3(1) (r) of SC&ST(PA) Amendment Act-2015.**

Sixthly, on above said date, time and place, you accused No's.1 to 7 knowing fully-well that, CW's.1 & 4 to 6 belonged to Hindu-Madiga sub-caste, coming within the category of Scheduled Caste, abused them in filthy language in the

name of their sub-caste, intentionally to insult and degrade them in the public view and caused the atrocity against them and thereby, committed the offence punishable **U/Sec.3(1)(s) of SC&ST(PA) Amendment Act-2015.**

Lastly, on above said date, time and place, you accused No's.1 to 7 knowing fully-well that, CW's.1 & 4 to 6 belonged to Hindu-Madiga sub-caste, coming within the category of Scheduled Caste, committed the offences against them punishable with imprisonment and fine under the BNS-2023, as specified in the schedule of the Act and thereby, committed the offence punishable **U/Sec.3(2)(va) of SC&ST(PA) Amendment Act-2015.**
