Accused is my family friend. I do not know the cheque number given by the accused. Cheque has been given by the accused to me. Cheque has been given by the accused to me on 02-02-2025. I have not produced my bank statement before this court. Ex P.1 cheque contents has been written by me. I do not remember the account number of the accused. My account number is 10613101009628. I have not got written any document from the accused at the time of giving of money by me to accused. It is true to suggest that, I have given the money to accused during the year 2023. It is false to suggest that, I have taken interest from the accused at the rate of 3% per month. It is false to suggest that, by 2024 I have taken the principal as well as interest amount from the accused. It is false to suggest that, after taking the amount from the accused I was absconding since from the year 2024. It is true to suggest that, I have obtained bail and returned back. It is false to suggest that, my father has taken the remaining amount of Rs.18,000/- from the accused. By selling the land the amount of Rs.5,00,000/- was with me. To show that, I have sold out the land and I have received consideration amount,

I have not produced the document before this court.

It is false to suggest that, during the year 2022 my father has given an amount of Rs.2,00,000/- to accused. It is false to suggest that, on 04-04-2022 an amount of Rs.1,00,000/- is given by my father to accused and I have not given any money to accused. It is false to suggest that, on 19-04-2022 an amount of Rs.2,00,000/- is given by my father to accused. It is false to suggest that, on 28-04-2022 an amount of Rs.2,00,000/- is given by my father to accused. It is false to suggest that, the above said transaction has taken place between my father and accused and there is no any transaction between myself and accused. During the month of June-2025 my counsel has issued legal notice to accused. It is true to suggest that, the contents of the legal notice at para No.2 are true and correct. I have not given any money to accused on interest. It is false to suggest that, I have not mentioned in my legal notice that accused is entitled to pay interest. It is true to suggest that, my signature is not appearing in the legal notice issued to accused. It is true to suggest that, the contents of my chief affidavit at Para No.1 are true and correct. After one and an half year of lending of money to accused has given the cheque to me. It is true to suggest that, accused is known to me since from the last 10-12 years. It is true to suggest that, there is no any

hostility between myself and accused. It is false to suggest that, accused is not entitled to pay any money to me and there is transaction between my father and accused and there is no any transaction between myself and accused. I have not mentioned in my chief affidavit at Para No.4 claiming interest at the rate of 24% per annum. It is false to suggest that, I have not mentioned in my legal notice that the accused is entitled to pay interest at the rate of 2% per month. I am having cold drinks shop. I earn an amount of Rs.1,50,000/- per year from said business. I do not have any other income other than the cold drinks shop. My father also does the business of Cold Drinks shop. It is true to suggest that, my father is also not having any other income other than cold drinks shop. It is false to suggest that, I have filed false case, false affidavit and deposing falsely before this court.
