COMMITTAL ORDER

The PSI of Market Yard P.S, Raichur filed Charge-sheet against the accused Nos.1 to 4 and 8 in Crime No. 43/2025 of Market Yard P.S,. The offences alleged against the accused are punishable under Section 189(2), 191(2), 191(3), 352, 118(1), 118(2), 109 R/w Sec.190 of BNS.

2. The offence punishable under Section 109 of BNS is triable by the Court of Sessions and this court has no jurisdiction to try the above said offence.

3. The accused are enlarged on bail. The accused Nos.1 to 4 and 8 is directed to execute bond of Rs.1,00,000/- each and to furnish one surety for appearance before the Hon'ble Dist and Sessions Court, Raichur, whenever summoned.

4. The office is directed to notify the committal of this case to the learned Public Prosecutor, Raichur.

5. Further the office is directed to submit the entire records duly indexed to the Hon'ble Principal District and Sessions Court, Raichur along with the properties if any.

ORDER

The case is committed for trial to the Hon'ble Principal District and Sessions Judge Court, Raichur.

Submit the entire records of the case along with properties, if any, to the Hon'ble Court of Sessions.

Intimate the learned Public Prosecutor, Raichur.

The accused Nos.1 to 4 and 8 are directed to appear before the concerned Hon'ble Sessions Court, Raichur, as and when summoned.
