MM advocate filed application U/Sec.437 of Cr.P.C along with power for accused no.12 and also filed memo along with copy of order.

ORDER ON BAIL APPLICATION

FILED U/S 437 OF CR.PC.

The accused no.12 has filed an application U/Sec.437 of Cr.P.C for the offences punishable U/s.143, 147, 148, 324, 354, 506 R/w 149 of IPC along with copy of the Order passed in Crl.Misc.no.1086/2023 dated 28.11.2023 wherein accused no.12 was granted anticipatory bail in connection with Cri.no.62/2023 (CC.No.72/2024) of Jalahalli PS subject to conditions mentioned therein. The accused no.12 has not committed any offences as alleged. He has hail from respectable family. If he is enlarged on bail, he will abide by conditions that may be imposed by this court. Accordingly, prayed for allowing the application.

Learned APP submitted orally objected.

Heard the accused no.12 counsel.

Perused the materials available on record. The accused no.12 has already obtained anticipatory bail from the II-Addl. District and Sessions Judge, Raichur. Considering the said fact and in the light of the order passed in Crl. Misc. no.1086/2023. This court is of the opinion that the bail application of accused no.12 deserves to be allowed on imposing suitable conditions. Accordingly, the bail application filed by the accused no.12 is hereby allowed and the accused no.12 is hereby ordered to be released on bail subject to his executing personal bond for sum of Rs.50,000/- with one surety for all together for like sum, subject to conditions mentioned in the order of the II-Addl. District and Sessions Judge, Raichur. in Crl.Misc.no.1086/2023, dated 27.11.2023.

One surety namely Hanumantraya S/o. Dyavappa, Aged about 45 years, Occ Agriculture, R/at Sunnadakal village, Devadirga Taluk and Raichur District is present and filed his surety affidavit stating that he knows the above said accused no.12 and he is ready and

willing stand as surety and also abide by the conditions imposed by this court along with attested copy of Aadhaar Card No.3607 1276 2702 and RTC bearing Sy.No.101/*2 measuring of 01 Acre 07 guntas situated at Sunnadakal village, Devadurga Taluk and Raichur District. Perused, satisfied and accepted.
