ORDERS ON IA NO. III :-

This is the application No. III filed by the defendant No.11 permission to file his written statement of this suit. In the affidavit It is averred to the application. originally the plaintiff has filed suit for the relief of partition and separate possession against defendants in respect of suit schedule property. It is also averred that due to non availability of the documents. defendant could not

contact their counsel to instruct to him to filed written statement as such written statement on his behalf could be filed in this case. The delay in non filing of written statement is not intentional. If this application is allowed know hardship will be caused to plaintiff. Per contra if this application is not allowed the defendants will put to grate hardship before pray to allow the application in interest of justice. On receipt of application learned counsel application has filed objection contending that the application is not maintainable ether in law or fact also. Objection taken as not filed to the IAs.

On the basis of the application and objection filed following points arise for my consideration.

1. Whether the defendants No.11 has made out sufficient ground to allow this application ?
2. What order?
3. My answer to the above point is as under.

Point no.1:- At the outset it is the suit for the relief of partition and separate possession in respect of suit schedule property against defendants. Hence under such circumstances the right of the parties needs to the

adjudicated, as such he need to be give on opportunity to defend their right suit property. Further on perusal of order sheet, defendants No. 11 appeared through his counsel on 06-11-2024 but all these days they has not filed written statement. As such, if application as prayed for is allowed, there will be delay is proceedings. But only delay in filling the written statement shall not deny the opportunity to defendant to defend their right with respect of suit property. As such in my view by imposing suitable cost, the defendants can be permitted file their written statement. Hence, the defendants has made out sufficient ground to allow this application. Accordingly I answer to the point no.1 in the Affirmative.

Point no.2:- In view of discussion arrived at point no.1 IA no. III deserves to be allowed. Hence I proceed to pass the following,

Application No. III filed by the defendant 11 u/s 151 of CPC is hereby allowed on cost of Rs. 200/- Cost to be paid . W.S. and list of documents taken on record. For compliance of section 89 of CPC.
