ORDER

The present petition has filed U/Sec.13(3) of
Registration of Births and Deaths Act, 1969, seeking
directions to respondent to enter death details of
Lachamappa S/o Lingappa, R/o Janekal village,
Manvi town, Tq: Manvi and to issue death certificate.

FACTS IN NUTSHELL ARE AS UNDER:

2. The Petitioner is in need of death certificate of his father **Lachamappa S/o Lingappa** It is further averred that, **Lachamappa S/o Lingappa**, died on **05-03-1998** at his resident Janekal village, Tq: Manvi. The death date of deceased has not been intimated to the concerned authority due to oversight and inadvertent mistake. This fact has come to the notice to the petitioner, only after non-availability certificate issued by respondent. Hence this petition.
3. On receipt of petition notice, the respondents have placed exparte.
4. Trial consisted of examination of Petitioner no.1 as P.W1 and got marked Ex.P1-Non-Availability Certificate, Ex.P-2 is Aadhar card of petitioner , Ex.P-3 is Anganwadi report, Ex.P-4 is True copy of Ration card, Ex.P-5 is death certificate of petitioner's mother, Ex.P-6 and 7 are the paper publications, Ex.P-8 is Panchanama of Revenue department and closed the petitioners side evidence. None were examined on behalf of respondent.
5. Heard argument by petitioners side.
6. Upon hearing arguments and on perusal of materials

placed on records, following points would arise for consideration.

1. *Whether the Petitioners are made out grounds for allowing the Petition?*

2. *What order?*

7. My findings to the above points are as under:

8. **POINT NO.1:** In order to prove their case, petitioner no.1 has examined as PW.1 and reiterated the petition contents in his examination-in-chief affidavit. The respondents neither filed any objections nor produced any documents to show that the petitioners have filed false petition. Therefore there is no reasons to disbelieve the evidence given by petitioners side.
9. It is also trite that in a proceeding U/Sec.13(1)(3) of Registration of Births and Deaths Act, court is concerned with the factum of birth or death and date of birth or death is not relevant.

10. Reverting to the factual matrix of the present case, petitioners have deposed on oath that, their father died on **05-03-1998** at his resident at Janekal village, Tq: Manvi. The said fact is remained unchallenged. The material placed by the petitioners discloses that the death date of deceased has not been entered in the concerned register and no rival interested persons come forward to contest the petition inspite of paper publication. Hence in the light of principles emerged from the decision referred above, petition is deserved to be allowed. Therefore I answer the Point No.1 in the 'AFFIRMATIVE'.
11. **POINT No.2:-** For the foregoing reasons, I Proceed to pass the following;
