COMMITTAL ORDER

Police sub-inspector of Manvi police station has filed chargesheet against the accused the offence punishable U/s 3, 42, 43 KMMC rules 1994 & 4, 4(1A) MMDR Act 1957 & 379 of IPC r/w 3 and Sec 181, 180, 177 of IMV Act alleging ಆರೋಪಿತರಾದ ನೀವು ದಿನಾಂಕ: 30.11.2017 ರಂದು 09.45 ಗಂಟೆಗೆ ಯರಮಲದೊಡ್ಡಿ ಕ್ರಾಸ (ಡಿಗ್ರಿ ಕಾಲೇಜ್ ಕ್ರಾಸ್ ಮಾನವಿ) ಹತ್ತಿರ ರಾಜಲದಿನ್ನಿ ಗ್ರಾಮದ ಹಳ್ಳದಲ್ಲಿ ಕಳ್ಳತನದಿಂದ ಅಕ್ರಮ ಮರಳನ್ನು ತುಂಬಿಕೊಂಡು ತನ್ನ ಸ್ವಂತ ಲಾಭಕ್ಕಾಗಿ ಮಾರಾಟ ಮಾಡುವ ಉದ್ದೇಶದಿಂದ ಯಾವುದೇ ಪರವಾನಿಗೆ ಇಲ್ಲದೇ ಅನಧಿಕೃತವಾಗಿ ಮತ್ತು ಸರಕಾರಕ್ಕೆ ರಾಜಧನ ತುಂಬದೇ ಕಳ್ಳತನದಿಂದ ಮರಳನ್ನು ಸಾಗಿಸಿದ್ದು ಇರುತ್ತದೆ. The police during the course of investigation recorded statements of the witnesses, obtained documents in connection with the alleged offences and file the chargesheet.

After filling of chargesheet cognizance has taken for the offence punishable U/s 3, 42, 43 KMMC rules 1994 & 4, 4(1A) MMDR Act 1957 & 379 of IPC r/w 3 and Sec 181, 180, 177 of IMV Act copies of prosecution papers were furnished to the accused as required U/S.207 of Cr.P.C. Heard learned APP and counsel for accused on the committal of case.

On perusal of entire charge sheet it appears that there is reasonable grounds to believe that accused is committed the alleged offence made

against him by the police. Since the accused is abated offence punishable U/s 3, 42, 43 KMMC rules 1994 & 4, 4(1A) MMDR Act 1957 & 379 of IPC r/w 3 and Sec 181, 180, 177 of IMV Act which is exclusively tribally by the Hon'ble special court. I am of the opinion that it is a fit case to commit to the Hon'ble special court. Hence, I pass the following:

ORDER

Acting U/S.209 of Cr.PC the case against the accused No. 1 to 4 hereby committed to Hon'ble Prl. Dist and Special Court Raichur for trial.

During the course of investigation accused are released on bail on the direction of JMFC, Manvi court. Hence, the accused is released on bail with some condition.

The accused are hereby directed to appear the before the Hon'ble Dist and Special Court Raichur whenever he is directed to appear.

Office is directed to send the entire records and articles if any produced to this court to the Hon'ble Special court Raichur.

Notify the Public Prosecutor of Dist. and Special Court Raichur about the committal order being passed by this court.

Accused No.3 Surety by name: Ramayya S/o Yankoba, Age:41 yrs, occ: Agril r/o Daddal Village, Tq:Manvi, Dist: Raihcur present and filed his affidavit and declaration along with RTC extra and Xerox copy of Aadhar card.

Accused No.4 Surety by name: Earanna S/o Lokamma Harijan @ Lukamma, Age:67 yrs, occ: Agril r/o Yaramal Doddi Village, Tq:Manvi, Dist: Raihcur present and filed his affidavit and declaration along with RTC extra and Xerox copy of Aadhar card.

Perused and satisfied the surety and accepted the same.
